begs leave to report as follows:

The purpose and intent of this measure is to designate  
January 22-28, 2012, as "Reproductive Rights Awareness Week".

Your Committee received testimony in support of this measure  
from Hawaii Youth Services Network, Community Alliance on Prisons,  
and one individual.

Your Committee finds that recently, women's reproductive  
rights have been receiving much national attention, and according  
to the Guttmacher Institute, in 2011, over a thousand state laws  
regarding women's reproductive health and rights were introduced  
across the nation. Reproductive Rights Awareness Week will create  
an opportunity to disseminate information, boost public awareness,  
and support for reproductive rights in the State and will  
encourage maternal, family, and child wellbeing.


Your Committee has amended this measure by:



- (1) Changing the designated date of Reproductive Rights Awareness Week to the fourth week of January of every year, rather than from January 22-28, 2012;
- (2) Changing the title to reflect the amended date; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

As affirmed by the record of votes of the members of your Committee on Health that is attached to this report, your Committee concurs with the intent and purpose of H.C.R. No. 12, as amended herein, and recommends its adoption in the form attached hereto as H.C.R. No. 12, S.D. 1.
