Sir:

Your Committee on Water, Land, and Housing, to which was referred H.C.R. No. 162 entitled:

"HOUSE CONCURRENT RESOLUTION AUTHORIZING THE GRANT OF A FIFTY-FIVE YEAR TERM FOR A NON-EXCLUSIVE EASEMENT TO KOOLAU PROPERTIES, LLC, FOR SEAWALL PURPOSES AT SPRECKLESVILLE BEACH LOTS, WAILUKU, MAUI, AS APPROVED BY THE BOARD OF LAND AND NATURAL RESOURCES,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the issuance of a fifty-five year term, non-exclusive easement covering an approximately 2,030 square foot portion of state submerged lands identified as seaward of tax map key: (2) 3-8-002:51 at Spreckelsville Beach Lots, Wailuku, Maui for a seawall.

Your Committee received testimony in support of this measure from the Department of Land and Natural Resources.

Your Committee finds that the Board of Land and Natural Resources approved the issuance of a fifty-five year term, nonexclusive easement to Koolau Properties LLC for a seawall constructed at Spreckelsville Beach Lots. Koolau Properties LLC has paid the easement's fair market value of \$53,400 plus fees on November 17, 2011. This measure fulfills the legislative authorization requirement under section 171-53, Hawaii Revised Statutes, for the leasing of state submerged lands.

As affirmed by the record of votes of the members of your Committee on Water, Land, and Housing that is attached to this
