The purpose of this measure is to:

- (1) Allow geothermal resources exploration and geothermal resources development in all state land use districts and all zones of the conservation district; and
- (2) Repeal the geothermal resource subzone provisions in the state land use law.

The Department of Land and Natural Resources; Department of Business, Economic Development, and Tourism; Innovations Development Group; Pacific Resource Partnership; Indigenous Consultants, LLC; and Ormat Technologies, Inc., supported this measure.
