The Corporation is a recently established entity that is responsible for land and development issues that heavily impact the State. As affirmed by the record of votes of the members of your Committee on Water, Land, and Housing that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 175 and recommends its adoption.
