Your Committee on Human Services, to which was referred S.C.R. No. 84 entitled:

"SENATE CONCURRENT RESOLUTION URGING THE HAWAII PUBLIC HOUSING AUTHORITY TO APPLY FOR A CHOICE NEIGHBORHOODS GRANT,"

begs leave to report as follows:

The purpose and intent of this measure is to urge the Hawaii Public Housing Authority to apply for a United States Department of Housing and Urban Development Choice Neighborhoods Grant.

Prior to the hearing, your Committee posted a proposed S.D. 1 of this measure for public review and comment. The proposed S.D. 1 amended this measure to support the Hawaii Public Housing Authority's application for a Choice Neighborhoods Grant and to urge the United States Department of Housing and Urban Development to select the Authority as a Choice Neighborhoods Grant recipient.

Your Committee received testimony in support of the proposed S.D. 1 from the Hawaii Public Housing Authority and one individual.

Your Committee finds that the Hawaii Public Housing Authority is currently in the process of applying for a Choice Neighborhoods Planning Grant. In 2011, the Authority was among seventy-one applicants that met the threshold criteria for a Choice Neighborhoods Planning Grant. Unfortunately, due to federal fiscal constraints, the Authority was not among the thirteen planning grants awarded and therefore did not have the funding to

undertake the necessary steps to develop the required transformation plan that supports the application for an implementation grant.

Your Committee further finds that the United States
Department of Housing and Urban Development anticipates awarding
as many as twenty planning grants under the fiscal year 2012
Notice of Funds Availability. Therefore, the Authority is
focusing its efforts on obtaining a planning grant to develop a
transformation plan that will be submitted for a full
implementation grant. Accordingly, the proposed S.D. 1 supports
the Authority's application for a Choice Neighborhoods Grant and
urges the United States Department of Housing and Urban
Development to select the Hawaii Public Housing Authority as a
Choice Neighborhoods Grant recipient.

Your Committee has amended this measure by adopting the proposed S.D. 1.

As affirmed by the record of votes of the members of your Committee on Human Services that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 84, as amended herein, and recommends its adoption in the form attached hereto as S.C.R. No. 84, S.D. 1.
