Your Committees received testimony in support of this measure from the Public Land Development Corporation; International Longshore and Warehouse Union Local 142, Hawaii Division; Indigenous Consultants, LLC; Innovations Development Group; and Outrigger Enterprises Group. Your Committees received comments on this measure from the Department of Land and Natural Resources and Aupuni O Hawaii.

Your Committees find that it is necessary to bring together state and county agencies to address the serious financial and employment needs and failing tourism infrastructure in East Hawaii

The Public Land Development Corporation was established to optimize the use of public lands for recreation and leisure activities or for revenue generation, including through partnerships with the private sector that would increase work opportunities.
