Establishes a process by which licensed or certified, unbiased real estate appraisers are used for arbitration proceedings to determine the fair market value, fair market rental, or fair and reasonable rent of real property. Requires the Department of Commerce and Consumer Affairs to provide a list of appraisers meeting certain criteria.

Effective July 1, 2112. (HB1830 HD1)
