SB2429 RELATING TO FORECLOSURES. CPN, JDL

Status and Testimony Implements the 2011 recommendations of the mortgage

foreclosure task force to address various issues relating to the mortgage foreclosures law and related issues affecting homeowner association liens and the collection of unpaid

assessments.

action or foreclosure by power of sale.

court for services rendered by the bureau of conveyances for two

years.
