SB 2106, SD1 (SSCR2185) Status & Testimony	RELATING TO HEALTH. Requires health insurers to provide outpatient prescription drug coverage. Prohibits health insurers, other than mutual benefit societies, from requiring coinsurance as a basis for cost sharing with the insured for outpatient prescription drug benefits and limits the amount of copayments an insured must pay for prescription drugs.
