### RELATING TO CHALLENGE COURSE TECHNOLOGY.

ERB/TOU, CPC/JUD, FIN

Establishes standards and regulations for operators of ziplines and canopy tours. Requires operators to obtain annual inspections and permits from the Department of Labor and Industrial Relations.

#### DECISION MAKING TO FOLLOW
