HB 2793 (HSCR556-12)

<u>Status</u>

RELATING TO BOARD OF LAND AND NATURAL RESOURCES. Adds 4 members to the board of land and natural resources who shall

be considered in determining quorum and majority only on issues relating to ocean resources and may vote only on ocean resources

issues.

HB 2553, HD1 (HSCR555-12) Status

RELATING TO BUILDING DESIGN FOR PERSONS WITH

DISABILITIES.

Requires the Disability and Communication Access Board (DCAB) to charge fees to defray expenses of reviewing construction plans to ensure compliance with law, establishes a fee schedule to be effective January 1, 2013, and requires the fees to be deposited into the DCAB

special fund.

HB 2589, HD2 (HSCR648-12)

<u>Status</u>

RELATING TO VESSELS.

Clarifies responsibility for disposing of vessels and amends the

description of an abandoned vessel.

HB 1793, HD2 (HSCR633-12) Status

RELATING TO CONSERVATION AND RESOURCES.

Establishes penalties for the destruction or harvesting of native forest resources including the sandalwood tree. Establishes Department of Land and Natural Resources policies and rules to protect native forest

resources. Effective January 7, 2059.

HB 2246, HD1 (HSCR620-12) Status

RELATING TO HAIKU VALLEY.

Establishes the Haiku Valley cultural preserve commission to provide policy and management oversight of the Haiku Valley cultural

preserve. Initiates process of conveying Haiku valley in fee simple to

the Department of Land and Natural Resources.

HEARING FIN 02-29-12 4

RELATING TO LAND USE. WLO/HAW, FIN HB 2398, HD1 Establishes the Honokohau marina development district on the island (HSCR619-12) of Hawaii. Status RELATING TO LAND USE. WLO, FIN HB 2384, HD1 (HSCR474-12) Requires the land use commission, upon request, to extend the time period for which a boundary amendment is effective for at least 2 years Status if the appropriate county officer or agency determines that the petitioner has substantially commenced development or if other good cause exists. RELATING TO LAND USE. WLO, FIN HB 2419, HD1 Allows counties to seek declaratory ruling from the land use (HSCR475-12)

commission for reclassification of lands under a county general plan or Status county development plan. Specifies that changes to the general plan take effect immediately upon approval of the reclassification by the

land use commission.
