available without charge.

SB 1312 (SSCR2557) RELATING TO THE LEGACY LAND CONSERVATION

COMMISSION. Status

Authorizes the Chairperson of the Natural Area Reserves System Commission to designate a representative from the Natural Area Reserves System Commission to serve on the Legacy Land Conservation Commission and authorizes the members of the Legacy

Land Conservation Commission to elect their own chairperson.

SB 2236, HD1 (HSCR1127-12) RELATING TO INFORMATION TECHNOLOGY.

Authorizes the issuance of special purpose revenue bonds to assist Clearcom, Inc., or a partnership headed by Clearcom, Inc., with planning, permitting, designing, constructing, equipping, and operating

Authorizes the issuance of special purpose revenue bonds for Le Jardin Academy for the planning, acquisition, construction, improvement, and

equipping of its educational facilities.

Effective January 9, 2059. RELATING TO THE PRESERVATION OF HAWAII'S MOVING HED, FIN SB 2110, SD1 IMAGES. (HSCR1027-12) Designates 'Ulu'ulu: The Henry Ku'ualoha Giugni Moving Image Status 5 4 1 Archive of Hawai'i as the state archive for moving images; establishes a special fund. HAW, FIN RELATING TO THE DEPARTMENT OF HAWAIIAN HOME SB 2790, SD1 LANDS. (HSCR1034-12) Extends the repeal date in Act 187, Session Laws of Hawaii 2010, to Status continue the pilot project that enables the Department of Hawaiian Home Lands to begin housing and other projects without having the full amount of the cost of the projects on hand at the start of the project. Requires report to the legislature no later than twenty days
