SB 2386, SD2, HD2 (HSCR1318-12) Status

RELATING TO THE NATIVE HAWAIIAN ROLL COMMISSION. Requires the Native Hawaiian Roll Commission to be responsible for verification documents from individuals seeking to be included in the roll of qualified Native Hawaiians. Notwithstanding any other law to the contrary, requires verification documents to be kept confidential. Clarifies that the roll commission is prohibited from publishing or releasing any verification documents of any qualified Native Hawaiian on the roll. (SB2386 HD2)

HAW, JUD, FIN

SB 2739, SD2, HD1 (HSCR1128-12) **Status**

RELATING TO THE SMALL BUSINESS REGULATORY REVIEW BOARD.

ERB, FIN

Authorizes the small business regulatory review board to require an agency to conduct another public hearing on a rule change when the rulemaking agency declines to make changes requested at the first hearing and the agency's small business statement, submitted after the hearing, indicates inconsistency with its earlier determination or does not address the public's concerns. Effective July 1, 2112. (SB2739)

SB 2584, SD1 (HSCR1196-12) Status

RELATING TO TUITION ASSISTANCE.

PBM, HED, FIN

Broadens the scope of the tuition assistance to Hawaii National Guard members attending the University of Hawaii and appropriates funds for

that purpose. (SD1)

SB 2248, SD2, HD2 (HSCR1273-12) Status RELATING TO PUBLIC SAFETY.

PBM, JUD, FIN

Requires the Department of Public Safety to assess and refer inmates to the Hawaii Paroling Authority (HPA) for possible medical release. Provides that an inmate in the custody of the Department shall be eligible to be considered for medical release if the inmate meets specified criteria under certain procedures. Requires HPA to set reasonable conditions on an inmate's medical release. Requires the HPA to promptly order an inmate returned to custody of the Department to await a revocation hearing if the HPA receives credible information that an inmate has failed to comply with any reasonable condition set upon the inmate's release. Effective July 1, 2012. (SB2248 HD2)

SB 650, HD1 (HSCR1268-12) Status

PROPOSING AN AMENDMENT TO ARTICLE VI, SECTION 3, OF JUD, FIN THE CONSTITUTION OF THE STATE OF HAWAII

AUTHORIZING THE CHIEF JUSTICE OF THE STATE SUPREME

COURT TO APPOINT RETIRED JUDGES TO SERVE AS EMERITUS JUDGES.

Proposes a constitutional amendment authorizing the Chief Justice of the Supreme Court to appoint judges who have retired upon attaining the age of seventy years as emeritus judges, permitting the appointed judges to serve as temporary judges in courts no higher than the court level they reached prior to retirement and for terms not to exceed three months. (SB650 HD1)

SB 2737, SD1, HD1 (HSCR1144-12) Status RELATING TO PUBLIC MEETINGS.

JUD, FIN

Permits use of interactive conference technology to increase ability of members of state and county boards and commissions to attend board meetings. Establishes requirements for notice and use of visual aids. Effective July 1, 2012. (SB2737 HD1)

SB 2304, SD2, HD1 (HSCR1219-12) Status RELATING TO RIGHTS OF THE ACCUSED.

JUD, FIN

Establishes procedures for eyewitness identification in live lineups and photo lineups of persons who are suspected of committing an offense. Effective July 1, 2050. (SB2304 HD1)

DECISION MAKING TO FOLLOW
