RELATING TO MEDICAID.

Establishes a formula for calculating the amount to be contributed by the State, towards a claimant's attorney's fees and costs, in lieu of recovering the full amount. Defines the term "medical institution". Clarifies that the lien amount in the Notice of the Lien sent by the Department of Human Services for reimbursement of Medicaid benefits shall be presumed to be valid. Effective January 7, 2059. (HB2448 HD2)
