Status & Testimony Exempts expenditures less than \$250,000 from the Hawaiian Home Operating Fund, Hawaiian Home Receipts Fund, Hawaiian Home Trust Fund, Native Hawaiian Rehabilitation Fund, and Hawaiian Home Administration Account from the Hawaii Public Procurement Code. Requires the Department of Hawaiian Home Lands to submit an annual report to the Legislature. Effective July 1, 2012, and repealed on June 30, 2015. (HB2529 HD1)

Amends the deadline to file nomination papers associated with filling a vacancy in the membership of the board of trustees of OHA, to ensure compliance with provisions of the National Defense Authorization Act for Fiscal Year 2010, P.L. 111-84, mandating the mailing of absentee ballots to uniformed and overseas voters no later than forty-five days prior to an election.
