RELATING TO OPIHI HARVESTING AND POSSESSION

RESTRICTIONS.

Establishes a ban on taking or harvesting opihi statewide, subject to open and closed sessions and traditional gathering rights and practices. Prohibits the taking or harvesting of opihi in an amount greater than one quart with shells attached or one half pint without shells per day. Requires the department of land and natural resources to submit an annual report regarding effectiveness and enforcement. Establishes until 06/30/17 a moratorium on the harvesting of opihi on Oahu.
