Prohibits use of tobacco products by minors. Authorizes law (SSCR2352) enforcement officer to confiscate tobacco products used by

Status & minors. Effective 1/1/2050. (SD1) **Testimony**

SB 226, SD1 RELATING TO PROSTITUTION. PGM, JDL

Authorizes an arresting officer to place or caused to be placed at (SSCR2321) the time of the arrest a wheel clamp or wheel boot of the vehicle Status & used by the person in the course of committing certain crimes of **Testimony** prostitution. Provides for additional fine to be deposited into the domestic violence and sexual assault special fund and the

county general fund. Makes grant-in-aid to each county to

purchase wheel clamps or wheel boots. (SD1)
