RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM.

To prevent unexpected increases in pension benefits and in the unfunded actuarial accrued liability of the Employees' Retirement System by limiting the amount of compensation included in "average final compensation" and requiring employers to pay the additional

costs resulting from spiking. Effective 7/1/50. (SD1)

Amends the definition of "employment" in various sections of the Hawaii Revised Statutes by clarifying the "domestic services" exclusion for services to persons with developmental and intellectual

disabilities. (SD1)
