SB 2237 RELATING TO TAXATION. WAM

Status & Amends distribution of partial payment of taxes to principal first, then penalties, then interest.

SB 2298 RELATING TO TAXATION. WAM

Status & Requires the department of taxation to report tax revenue by island and annually report the previous tax year's tax revenue by island to the legislature no later than March 1 of each year.

SB 2867 RELATING TO CONFORMITY OF THE HAWAII INCOME TAX WAM

SB 2012 RELATING TO PUBLIC FUNDS. WAM

Status & Issues general obligation bonds to fund the repair and maintenance or capital renewal and deferred maintenance projects of various departments, the University of Hawaii, Hawaii

health systems corporation, and the judiciary. Requires that capital improvement projects authorized pursuant to this Act for goods, services, or construction less than \$1,000,000 to use

section 103D-305, HRS, as the method for procurement.

Requires procurements of less than \$1,000,000 to be conducted through an electronic system. Specifies that section 103D-701, HRS, shall not apply to capital improvement projects that are

less than \$1,000,000. Provides for certain exemptions from county permitting, licensing, and certification requirements.
