Representative Yamane rose to speak in support of both measures with reservations, stating:

"Mr. Speaker, on Stand. Com. Rep. No. 1522 and 1523, urging the inclusion of the People Republic of China in the visa waiver program. I would like to just express my reservations on the measure. From past discussions regarding national security issues, the visa waiver program was set up to allow those countries to have an expedited process for getting visas to visit the United States. With the past history of some tensions regarding the downed B-22 bomber and some other issues regarding China's encroachment on some friendly nations like the Philippines, I do have some reservations. Thank you."

Representative Cullen rose and asked that the Clerk record an aye vote with reservations for him on both measures, and the Chair "so ordered."

Representative M. Lee rose in support of both measures with reservations and asked that her written remarks be inserted in the Journal, and the Chair "so ordered."

Representative M. Lee's written remarks are as follows:

"Mr. Speaker, I rise with reservations. I am not certain we are ready for the volume of tourists we might receive from this waiver. We will need to do a lot more evaluation of the industry regarding language and customs before we are able to service a large number of these tourists. For the future it is a good idea, but premature."

Representative Cabanilla rose to speak in support of both measures, stating:

"In strong support, Mr. Speaker. And I just would like to say that they are very good allies with Hawaii, and they will bring commerce to our islands should that waiver be granted. Thank you, Mr. Speaker."

Representative Rhoads rose to speak in support of both measures, stating:

"Mr. Speaker, in support. Just briefly. I would say that I understand how the waiver system works, but I think in this case we're protected to a large degree by the fact that it costs a lot of money to get here. And if we're concerned about just everyone coming to Hawaii, I don't think we have to worry just for financial reasons."

No. 59, HD 1, entitled: "HOUSE CONCURRENT RESOLUTION URGING THE UNITED NATIONS TO GRANT TAIWAN PARTICIPATION AS AN OBSERVER IN THE UNITED NATIONS FRAMEWORK CONVENTION ON CLIMATE CHANGE CONFERENCE OF THE PARTIES," was adopted, with Representative Thielen being excused.

Representative Keith-Agaran, for the Committee on Judiciary presented a report (Stand. Com. Rep. No. 1527-12) recommending that H.C.R. No. 114, as amended in HD 1, be adopted.

Representative Chong moved that the report of the Committee be adopted, and that H.C.R. No. 114, HD 1, be adopted, seconded by Representative Evans.

Representative Johanson rose to speak in opposition to the measure, stating:

"Thank you, Mr. Speaker. In opposition. My main point of opposition hinges on section 4 of this particular Resolution. Having worked for two years in Presidential Personnel tasked solely with facilitating, vetting and recommending candidates for presidential appointment that required Senate confirmation, what I just thought I would share with the Members is, as frustrating as it was at times not to be able to have a simple majority up or down vote. And I think the intent of the Resolution is certainly a good one.

"What I found in practice was that it actually forced the White House to come up with some more consensus candidates that had broad bipartisan support. And because many of these people have billions of dollars, and thousands of people under their direction, and they have vast, broad powers under the federal government, I found as difficult as it was, often for me, that it actually created a system where we found better candidates that probably served all of America's interests. So for those reasons, I wish to express my opposition. Thank you."

Representative Fontaine rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Ching rose and asked that the Clerk record a no vote for her, and the Chair "so ordered."

Representative Riviere rose and asked that the Clerk record a no vote for him, and the Chair "so ordered."

Representative Pine rose to speak in opposition to the measure, stating:

"Yes, in opposition, and some comments. I'm a proud descendant of one of our founding fathers, Alexander Hamilton, who's on the \$10 bill, and so I have a very interesting family and we have a tremendous reverence for the Constitution. I'm in opposition because of section 3, which urges the abolishment of the Electoral College.

"I am continually looking at the Constitution and reading the histories of our Founding Fathers and I am, every time, amazed at the complexity of the Constitution and how they really thought through every little part of government. They really wanted to make sure that every American, in a sense, was properly represented, both through the Senate and the House, as well as the Presidential elections. Certainly it has created a Republic that has made it very difficult, sometimes, to pass things, because everyone's views are certainly represented. But what's so special here is no one view is worth more than the other.

"So what is the Electoral College, Mr. Speaker? Basically, the Electoral College is, for every House Member, each state is given one vote, per House Member. And for every Senate Member, every state is given two votes. The House of Representatives is really supposed to represent the will of the people. The Senate, however is supposed to represent the will of the states. Our Founding Fathers wanted to do this because they wanted to make sure that a small state like ours was not any less than California.

"So through the electoral process, because we have two senators, which is equal to California that can easily outvote us, we actually have more power, and more votes in Hawaii through the electoral process. If we were to go back to a system where we just say, 'Hey winner take all. Every American vote wins an election.' Then Hawaii would be meaningless, because we wouldn't have two votes which is equal to California. People will no longer think that we're important, and Congress will no longer look upon us in the favor that they do in Presidential elections. So that's why I cannot vote for this Resolution, Mr. Speaker."

Representative McKelvey rose to speak in opposition to the measure, stating:

"Thank you very much, Mr. Speaker. Unfortunately, in opposition. My opposition is basically based upon the dangers of a Constitutional Convention. I just want to share a brief story with the Members. Back in the day, when I was an aide, when the Legislature was over at the Hemmeter Building, a Resolution was introduced calling for a Constitutional Convention for balanced budget amendment, something that everybody pretty much supported.

"But as the Resolution made its way through, a lot of groups from both the left and the right came in there very upset. And one of the things that came out through the process of Committee Hearing was, once the Constitutional Convention is called, anything can be brought to the Floor. There are no sacred cows. Title IX. The Native Hawaiian Entitlement Program. All of that's on the chopping block, or could be, as well as these other issues that other people have raised. And once it's in the Constitution, Mr. Speaker, it's in the Constitution. It can't be removed by act of Congress later on.

"I'm very concerned that while I appreciate the intent of the author, and I respect his passions, I just think it's a danger, because you're opening up a lot of issues and cans of worms that will affect both sides of the political spectrum. That's why at this point I just cannot support this Resolution. Thank you."

Thank you, Mr. Speaker."
