EDN, FIN

Amends section 302A-1143 to specify when a student may attend a school outside of the student's district. (SD1)

<u>HB280</u> RELATING TO AGRICULTURE.

AGR, FIN

Short form bill relating to agriculture.

HB2359 RELATING TO PORTABLE ELECTRONICS INSURANCE.

CPC, FIN

Establishes provisions for the sale of portable electronics insurance. Requires vendors to hold a limited lines license to sell

or offer coverage under a policy.

<u>HB2673, HD1</u> RELATING TO TOURISM.

TOU, FIN

Provides individuals occupying transient accommodations with the ability to donate \$1 to the Department of Land and Natural Resources for the State Park System. Authorizes acceptance of donations into the State Parks Special Fund. (HB2673 HD1)

HB2681 RELATING TO ELECTRIC GUNS.

PBM, FIN

Repeals the requirement that the Conservation and Resources Enforcement Program of the Department of Land and Natural Resources meet law enforcement accreditation or recognition standards of the Commission on Accreditation for Law Enforcement Agencies prior to using or obtaining electric guns,

related equipment, and training. Effective July 1, 2012.
