Personal Statement Lydia Kumasaka

Why do you want to be a member of the board of pharmacy?

In my role as an APRN, Nurse Manager I longed to volunteer my expertise to the community. Three or Four years ago I found an opportunity to offer my service to the University Of Hawaii School Of Nursing Undergraduate Student Affairs Committee as a community representative. I believe I am making an impact at the school of nursing by offering a valuable hospital based perspective. I continue my passion for community service and was seeking a board to volunteer for. In 2011 I was approached to entertain the thought of applying for the State Board of Pharmacy who was looking for a community member. Being that I have a passion for community service I would like to expand my expertise on quality and patient safety to the community at large.

My understanding of the role and responsibilities of the board:

As an interim community member of the Board of Pharmacy over the last few months I learned that my role and responsibilities are to assist in protecting public health and welfare. During the board meetings we review several topics such as individuals seeking a pharmacy license in the state of Hawaii, companies interested in conducting business in Hawaii, and to review rule and regulations over pharmacy practice in Hawaii. I have found being involved to be very interesting and beneficial. It has given me a better understanding of the role of the pharmacist, how their role impacts the community, and how a regulating entity is necessary to insure the well being of the people of Hawaii.
