I was hospitalized once again and became stable on my medications. Unfortunately, I didn't face my issues with substance abuse. Upon my return home to Maui and my family I became involved with Hale o Lanakila, the Maui Clubhouse. That is where my story of recovery actually begins. I wholeheartedly believe in recovery. Today I am a vital part of my community; I have been a strong advocate for my peers in mental health and substance abuse as a positive role model.

I have attached my current resume to this email. I feel that it exemplifies why I feel that I would be a valuable member of this board. I now have a supportive family and am looking forward to being even more active in my community as a Hawai'i Certified Peer Specialist. I am thankful to the State of Hawaii and the Adult Mental Health Division for educating me in so many areas and making me a better daughter, sister, mother, grandmother and making me see my self worth and ability to help others on their personal road to recovery.
