Confirmation Questions on regarding my qualifications to be approved for the Mental Health and Substance Abuse, Oahu Service Area Board.

- 1. Why do you wish to be a member of the Mental Health and Substance Abuse, Oahu Service Area Board? Why I wanted to be on the Mental Health and Substance Abuse, Oahu Service Area Board because of my desire to serve those consumers who need service that they continue to do so with programs that are funded by the government so that the unfortunate who have no money continue to receive services through the community health centers.
