Introduction

Chair Espero and members of the Committee, thank you for the opportunity to appear before you today. I want to thank the Procurement Nominating Committee for forwarding my name to the Governor's office and Governor Neil Abercrombie for nominating me. I am honored to be considered for a position on the Board.

Interest

I requested consideration for membership on the Procurement Policy Board because I know from experience that an effective, open and fair procurement system is critical to good government. Many of our vital State programs and significant portions of our State budget are executed through the procurement system. Proper operation of the procurement system can make the difference between success and failure on critical state programs and expenditures.

I have seen first-hand the amazing value the government can get from its contracts. I have also seen the terrible mess and loss of trust and confidence that occurs when things don't go well. A smoothly running procurement system with well-trained professionals enables open and fair competition while maintaining adequate safeguards to ensure public trust.

Qualifications

For the greater part of my professional life, I served in the United States Air Force. I retired in 2010 in the rank of Colonel after 25 years of service. Procurement was a common theme in my military career. In my first assignment, I was a cost analyst on the procurement of a major cargo aircraft system. In my last assignment, I was Chief Legal Counsel to Electronic Systems Center in Boston, Massachusetts, one of the Air Force's largest acquisition organizations with a procurement portfolio of over \$5 billion dollars. Throughout my Air Force career, I gained significant work experience in the fields of cost analysis, planning and programming, contract law, contract management, procurement integrity and ethics.

Prior to joining the Air Force, I worked for 7 years on the professional staff of the non-profit organization Junior Achievement teaching business and economics to school-age children.

I am currently Of Counsel with the law firm of Alston Hunt Floyd & Ing in Honolulu. My legal practice primarily involves providing advice on government procurement and ethics at the state and federal levels.

I hold a Juris Doctorate from the University of Washington, a Master of Science in Public Administration from the Central Michigan University and a Bachelor of Science in Economics from Portland State University. I have been admitted to practice law in Hawai'i, Washington State, and before several federal courts including the Supreme Court of the United States. I

continue to improve my professional education in procurement as an active member of the Aloha Chapter of the National Contract Management Association.

During my time in the Air Force, I was certified as a Cost Analyst and designated as a Judge Advocate. I recently completed National Contract Management Association certificate programs in Ethics Education for Introductory and Advanced Business Ethics for Federal Procurement. In the fall of 2011, I was approved as an Expert in Ethics and Government Contract Compliance by the General Counsel of a federal agency.

Goals

At this time, I have three broad goals for service on the Board. First, we need to ensure our actions enhance public trust in our procurement system. From my many years of public service, I understand the paramount importance of public trust, including business confidence that the procurement system will treat all competitors fairly. I believe public trust and business confidence can best be developed and supported by an open system that has clear rules that are consistently applied by a well-trained and experienced professional staff.

Second, our Procurement Policy Board must be responsive to requests from the State Procurement Office and the Chief Procurement Officers. We need to be prepared for all Board activities and engaged in resolving policy issues presented by the professional staff.

Finally, we need to use our experiences and capabilities to independently seek out and evaluate policy enhancements that may not otherwise be under consideration by the State Procurement Office. I believe we can add value to the State system by considering policy options and systems approaches from federal, state or local government procurement, commercial practices, discussions in professional publications and scholarly works, and fresh ideas based on our own experiences.

Conflicts of Interest

It is foreseeable that my work with Alston Hunt Floyd & Ing could cause actual or apparent conflicts of interest. The firm represents several state agencies and has numerous clients who do business with the State. However, the Board's enabling statute limits the Board to policy issues and forbids the Board from exercising authority over the award or administration of any particular contract, or over any dispute, claim, or litigation. In the event of an actual or potential conflict, I will disclose the issue to appropriate officials and determine how I can mitigate the conflict and whether I may need to seek recusal from the matter. You have my promise that I will always act in complete accordance with my duties as a Board member.
