Chair Baker, and Vice-Chair Taniguchi and members of the Committee, I am Warren Bollmeier, testifying on behalf of the Hawaii Renewable Energy Alliance ("HREA"). HREA is an industry-based, nonprofit corporation in Hawaii established in 1995. Our mission is to support, through education and advocacy, the use of renewables for a sustainable, energy-efficient, environmentally-friendly, economically-sound future for Hawaii. One of our goals is to support appropriate policy changes in state and local government, the Public Utilities Commission and the electric utilities to encourage increased use of renewables in Hawaii.

HREA **strongly supports** the nomination of Lorraine Akiba to join the Hawaii Public Utilities Commission as a Commissioner. We urge you to "advise and consent" on her nomination. We offer the following comments in support.

- (1) Resume Strong in Legal Experience including Regulated-Utility Matters.
 - Ms Akiba has over 30 years as a lawyer with substantial experience and strengths in negotiation and litigation, including working with Independent Power Producers to negotiate contracts to sell renewable energy to the utility, and to litigate disputes.
 - Thus, Ms. Akiba already comes not only <u>legally-trained</u> to the Commission, but with the kind of experience that is directly relevant to major issues before the Commission. For example, she is intimately familiar with issues related to integration of renewables on our grids, and thus provides the commission with an "alternate" legal view of appropriate paths to our renewable future.
- (2) The X-Factors. The above said, what else do we look for in a Commissioner:
 - Certain Physical and Personality Traits: integrity, intelligence, initiative, energy, openness, charisma. We see all of these traits in Ms. Akiba, as we attempt to describe "who she is" and "what she has done."
- (3) In Summary. We believe that Ms. Akiba will be a valuable addition to the Commission and we look forward to working with her.
