James Corcoran received his Ph.D. in Modern Chinese History and a Master of Arts in Asian Studies, concentrating on Chinese history from the University of Hawaii. He is currently an Assistant Professor of History and Asian Studies and Curriculum Area Liaison, History and Diplomacy and Military Studies for Military Campus Programs at Hawaii Pacific University. Mr. Corcoran has a strong interest in traditional Chinese medicine and acupuncture that he has shared with his students through his course curricula. Also, Mr. Corcoran has been a recipient of traditional Chinese medicine and acupuncture for many years, and can bring the patient perspective to the oversight functions of the Acupuncture board.

Mr. Corcoran is a member and current president of the Maunawili

Community Association, president of the Windward Civilian Military Council, and was an elected member to the City and County of Honolulu Kailua Neighborhood Board from 1999-2000. In those capacities, Mr. Corcoran gained valuable working knowledge of the state's sunshine law, as well as Hawaii's statutes and administrative rules.

Considering his extensive experience, I am confident that if given the opportunity, Mr. Corcoran will prove to be an asset to the State through his service to the Board. I respectfully request the Committee recommend that the Senate advise and consent to Mr. Corcoran's appointment.
