1. I wish to be a member of the Hawaii Health Authority to actualize my "career- long" belief that necessary health treatment, care, and support should be universally available to all of our citizens. More basically, perhaps, we need to strive for a healthy citizenry via education, prevention, and "walking the talk".

2. I perceive the role and responsibilities of a member of the Hawaii Health Authority to be a conscientious member who is vocal in opinion, collaborative in decision making processes, and dedicated to the pursuit of healthcare access statewide.

Authority members also need to be educated but open minded to all information and perspectives presented. They also need to be conscious of both opportunity and fixed costs, resource limitations, inefficiencies, and duplications.

Currently, I am a member of Senator Chun Oakland's Mental Health Task Force. I am also actively involved in the American Nurses Association's leadership activities. I will be a Hawaii delegate to the 2012 Annual Meeting in the D.C. area.

4. During my term of service, I hope to accomplish with and through the Authority the creation and implementation of major aspects of Hawaii's Universal Health System

- 5. Three qualities that best describe me and would make me a stand out are: 1) transparency; 2) personal educational and life experiences; and 3) focus on accomplishing the mission.
- 6. One previous experience that would make me stand out is my leadership in helping to achieve mental health parity in Hawaii. I was recognized by the American Psychological Association for this endeavor. I also chaired the Equal Insurance Coalition through which actionable legislation and implementing rules and regulations were promulgated. Lessons learned from both of these experiences may very well be transferable in carrying out Health Authority mandates.

I fully support Ms. Marion Poirier in her endeavor to be confirmed by the Committee on Health under your leadership.


