



Submitting for consideration and confirmation to the **Board of Physical Therapy**, Gubernatorial Nominee, **DEBRA T. KUBOTA**, for a term to expire on 6/30/2015.

Chair Baker and members of the Committee, thank you for the opportunity to appear before you today.

I want to thank Governor Neil Abercrombie for nominating me. I truly consider this an honor and a privilege to be considered as a Physical Therapist on the Board of Physical Therapy.

I want to also extend a warm mahalo to everyone that submitted letters of support on my behalf and to everyone here in attendance lending me their support and aloha.

I have been a physical therapist for 32 years. I was born and raised in Pasadena, California. I wanted a chance to explore my island roots since my maternal grandparents were both from the Big Island. I moved to Oahu in December 1979 and never looked back. My entire professional career as a physical therapist and administrator has been on Oahu. Since most of my life has been spent in the islands, I look forward to giving back to Hawaii's community and people, since I have been given so many incredible opportunities while living here.

Professionally, I have worked in a multitude of settings. My career began as a physical therapist with the Hawaii State Department of Health, servicing disabled children in the public schools. To gain experience in a clinical setting, I transitioned to working at the Rehabilitation

(Rehab) Hospital of the Pacific, where I became certified in the Neurodevelopmental Technique for stroke patients, and worked with the geriatric population. Experiences at Rehab Hospital included acute rehabilitation and outpatient clinics, as well as positions as a contract therapist with the Kuakini-at-Home (home health) and a joint business venture with the Queens' Medical Center (Mid-Pacific Rehabilitation—outpatient clinics). During my tenure at Rehab Hospital and Mid-Pacific Rehabilitation Centers, I was promoted from clinical positions (Staff Physical Therapist to Senior Physical Therapist), to administrative and managerial positions (Senior Case Manager and Quality Assurance Specialist to Director of Administrative Services and Acting Executive Director). For the past 18 years, I have been with Kaiser Permanente, transitioning from direct patient care in the hospital, skilled nursing facility and outpatient clinics to a managerial position, Supervisor of Rehabilitation Services, providing oversight to all of Kaiser Hawaii's outpatient physical therapy, occupational therapy and speech-language pathology services on Oahu and the Neighbor Islands.

My community involvement includes leadership roles in my church (President/
Corresponding Secretary for the Honolulu Teachers' Association) and our children's school
(Treasurer for Kailua Intermediate Band Boosters).

Professionally, I have been the Chair of the Hawaii Physical Therapy Association's Board of Physical Therapy (PT) Liaison Committee since 2005, attending the Hawaii State PT Board meetings on a regular basis. I have been very involved with promoting Board initiatives in the community including amendments to the Administrative Rules which became final in December 2010. These changes made Hawaii the 46th state to achieve alignment with the American PT Association's Vision 2020 which states that by the year 2020, consumers will have direct access to physical therapists (no physician referral required).

My participation with the PT Board as a "guest" for the past 7 years, along with the recent amendments to the PT Administrative Rules, have sparked my interest in serving the public by being a member of the PT Board, working together with PT leaders of our state to make decisions which will shape the future of our profession in Hawaii. My professional experiences working with all age ranges from pediatrics to geriatrics, as well as administrative and managerial roles in the fee-for-service as well as Health Maintenance Organization arenas, my current job responsibilities including oversight of therapists on Oahu and the Neighbor Islands, along with leadership roles in professional and community associations lend itself well to being a highly informed, responsible PT Board member.

My vision for the PT Board is to assure public protection and safety by establishing and updating a strong foundation of laws and regulatory standards which ensure that safe, competent and effective care is delivered by all physical therapy professionals. The Board must also assure that the profession in Hawaii is in alignment with national trends and developments.

In closing, I would like to thank this committee for all that you do for the State of Hawaii and for giving me the opportunity to be here today. Thank you for considering my nomination. If selected, you have my commitment that I will do my best to keep the public's best interest in mind while responsibly representing the physical therapy profession in the state. Again, thank you to everyone who submitted testimony on my behalf and to those who are here supporting me today.
