My response to questions posed in your 3/14/12 letter:

(1) Why do you wish to be a member of the Statewide Health Coordinating Council?

I firmly believe in the work of the Council, including its charge to prepare and revise as necessary the state health services and facilities plan and I have a long-standing commitment to the promotion of statewide health services.


(4) What do you hope to accomplish during your term of service?

Greene, President and CEO of the Healthcare Association of Hawaii (HAH), whose membership includes all of the acute care hospitals in Hawaii, two-thirds of the long term care beds, home care agencies and hospices, and other related provider organizations. Our provider members employ more than 40,000 people statewide, delivering quality care to the people of Hawaii. Thank you for this opportunity to testify in support of the nomination of Leonard Licina to the Statewide Health Coordinating Council.
