#### Response Re: Nomination to the Stadium Authority GM 808 ~ Odetta (Kealalio) Fujimori

- (a) Why do you wish to be a member of the Stadium Authority board?I believe in the mission of the Aloha Stadium. I want to be able to make a contribution to continue to provide a first class arena for our state and to make changes as needed to enhance that mission.
- (b) How do you perceive the role and responsibilities of a board member of the Stadium Authority board? The role and responsibilities/powers and duties are defined by Statute, (HRS 109-2)....basically, to maintain, operate and manage the stadium.
- (c) Given your understanding of the role and responsibilities of the Stadium Authority, why do you believe that you are qualified to serve as a member of its board? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability...

I believe I have a reasonable amount of skills for good decision making. I have served in "key" leadership positions built on trust and knowledge. My previous career utilized a team approach that is beneficial to serving on a Board, and finally, I am a team player who encourages collaboration and always striving for a "win-win" outcome.

Having served as an elected Trustee on the Employees' Retirement System Board (ERS), I am familiar with rules and regulations, including process and procedures expected of state agencies/boards. Finally, I pride myself with being a "sports spectator," and a bit knowledgeable with a whole array of sports. During my teens, I was on my high school tennis team, played volleyball and dared to challenge anyone at table tennis. Today, I stick to the game of golf. My children participated in gymnastics, soccer, baseball, basketball, capoeira and roller hockey. I have been a UH football season ticket holder since the opening of Aloha Stadium, and also have season tickets for UH basketball at the Stan Sheriff Center; and even prior to that, at the Blaisdell Center. For nearly ten years, we purchased UH Baseball season tickets and supported the team's fundraising efforts. I have done sports "fund-raisers," served as "team-mom," cleaned the parks for games and worked with city officials in encouraging the creation of roller hockey courts in the public parks. These experiences should enhance my decision making as a board member.

- (d) What do you hope to accomplish during your term of service? I hope we will be able to resolve any ceded land issue, relative to the Swamp Meet, with the US Department of Interior. I would also like to be part of the decision-making as to whether the Stadium Board trades land and/or builds a brand new stadium, and/or upgrades the facilities to last beyond my children's life-time. Finally, I hope we will be able to find additional ways to enhance the stadium revenues.
- (e) Have you reviewed the Auditor's recent report...What are your thoughts on the role of the Stadium Authority board in addressing the Auditor's recommendations? I believe the present board has addressed some of the recommendations, but there are others that the board should consider and seek ways to resolve some of the findings of the report.
- (f) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Stadium Authority? I am an eager learner/participant, a "people-person" and I do my "homework," which should be
  - beneficial to the Stadium Authority.
- (g) Name one previous experience that would make you stand out. How would this benefit the Stadium Authority?
  - An HSTA Strike Vote Meeting, attended by more than 5,000 teachers was becoming very hostile. As past president, and six months pregnant, I was called upon to conduct the strike vote. After four hours of parliamentary maneuvers, including demands from confrontational individuals, I was able to quell the unrest and fears of those in attendance. I believe my Parliamentary skills can benefit the Stadium Authority Board.
- (h) Can you foresee any possible conflicts of interests that could arise during your service on the Stadium Authority Board? How would you overcome any possible conflicts of interest? I do not foresee any conflicts of interests at this time but if any such conflict does occur, I will follow procedures to declare a conflict, including an abstention during a vote, if necessary.

Good afternoon, Senator Fukunaga and members of the Committee . Thank you for the opportunity to appear before you as you consider my nomination to the Stadium Authority, for a term to expire December 1, 2016.

For thirty-one years, I labored in the field of education as a classroom and special education teacher, a diagnostic-prescriptive teacher on a Special Services team, and one of two vocational education planners for special education at the district's Vocational Planning Center. I worked for a very short while for former governor Ben Cayetano when he served as lieutenant governor and ended my career as a resource teacher for the district's deputy superintendent. Sandwiched between my teaching profession and that of a mother, and having learned from my father, who was a union organizer, I spent many years at the state and national levels advocating for better schools and working conditions for our profession. Most of you know me as a former HSTA leader and I thank you for your past support. Since retirement (1995) my time in this building has been spent monitoring legislative bills affecting our retirees' pension and health benefits.

I have been a University of Hawaii Football season ticket holder since the Stadium opened in 1975, and have always had a desire to be a part of that decision-making body. Over the years, other things have taken priority, but today, I am ready to offer my services as a member of the Board. I am anxious to face the many challenges before the Board, including the recent Auditor's Report. Foremost, is to move forward in supporting the mission of the Aloha Stadium; that of a first-class sports and cultural arena. I thank Governor Abercrombie for this nomination.

Rather than being redundant, the written statement from questions that were requested by the Chair should provide you with sufficient information about my background, skills and knowledge. Hopefully, those kaleidoscope of experiences will earn your support and approval. I would be happy to clarify or to answer any questions.

Dear Ladies and Gentlemen of the Economic Development and Technology Committee:

I write this message in support of Odetta Fujimori's nomination to membership on the Stadium Authority. I have known Odetta since we were classmates at McKinley High School. Even then Odetta was extremely bright, very popular and friendly, and immersed in many school and extracurricular activity. She was a fierce competitor on the tennis team, and a solid planner and organizer on the Prom Committee. Odetta's parents were community activists, and their involvement as leaders in the union labor movement and social organizations were strong influences in Odetta's childhood that would inspire her to similar pursuits in her adult life.

I lost track of Odetta after high school. We both went on to college on the mainland. I did not know that she returned to Hawaii to finish her schooling in Special Education at the University of Hawaii' College of Education. After graduation, Odetta moved to the mainland to teach for a year. She returned to Hawaii and taught in the pubic school system where she was a pioneer specialist in the education of mentally retarded and emotionally disturbed students.

A strong believer in the idea that better education depended on better conditions for teachers, it would not be long before Odetta immersed her energies toward the creation of the Hawaii State Teachers Association (HSTA), and became its first president. With the same energy, passion, commitment and intensity that she displayed in her high school activities, she led the HSTA through almost insurmountable challenges to become a strong and respected organization in the state.

Such leadership never goes unnoticed, and it was not long before Odetta was directing her energies to the betterment of education----at the national level. She became a board member of the National Education Association (NEA), and during her 18 year tenure of the organization, she was the first Asian-American to be elected to its executive committee. During her NEA years, Odetta never tired of being the champion and advocate of better working conditions for teachers, and better programs for students. She was a major influence for reform and betterment within the NEA, and was awarded the NEA's first Silver Wings Award for her achievements and service.

After over 30 years in education, Odetta returned to Hawaii to retire. But as with all great leaders, she was as busy in retirement as when she was still at work. She became the vice president of the University of Hawaii College of Education's Alumni Association, was (and still is) an active committee member with the McKinley Alumni Association's Golf Tournament and Karaoke Show, is an active member of the McKinley Class of '57 Reunion Planning Group and editor of its newsletter, was a member of the state Employees' Retirement System's board of trustees, and a board member of the Hawaii Labor Heritage Council.

On Friday, January 27, 2006, Odetta was inducted into the McKinley High School Hall of Honor, an elite body of graduates from McKinley that includes Sen. Daniel Inouye, former Governor George Ariyoshi, the late former Sen. Hiram Fong, the late former Governor Samuel Wilder King, the late financier Chinn Ho, and many other notable personalities. For Odetta to be inducted into the company of such elite individuals speaks volumes of her own eliteness.

Odetta cares deeply about Hawaii and its people, and Hawaii is blessed to have such an experienced leader willing to continue to share her leadership skills with the Stadium Authority. Odetta is honest, sincere, caring, giving, and represents what makes Hawaii so great----the Aloha Spirit!

I fully and unequivocally support Odetta's candidacy for membership on the Stadium Authority's board. She will be an asset to that agency, and will serve it as she has served all of her previous positions;---with dignity, respect and humility.
