Chair Baker, members of the Senate Committee on Commerce and Consumer Protection. Thank you for this opportunity to present some background about myself in your consideration of my confirmation to the Contractors license Board.

I was born and raised on Oahu. I grew up in Manoa valley and attended Roosevelt High School. I moved to Kapahulu in 1990 where I presently reside there with my wife and daughter.
