Among her many recent community activities, Ms. Bantay has been involved with the Hawaii Covering Kids Ad Hoc Committee, the Interagency Council of Immigrant Service Providers, the Honolulu Catholic Diocese Prison Ministry, the St. Theresa Parish Pastoral Council, the Hawaii Coalition for Immigration Reform, and the Language Access Advisory Council.

Ms. Bantay holds a Bachelor of Science Degree in Commerce from Far Eastern University in the Philippines, a Master of Arts Degree in Theology from Maryknoll School of Theology in New York, and Master's Degree in Public Health from the University of Hawaii. She is also accredited by the U. S. Board of Immigration Appeals as an agency representative to represent immigration clients before the U. S. Citizenship and Immigration Services since 1994. In addition to English, Ms. Bantay speaks Tagalog and Spanish.

Honorable Chairs and members of the Senate Committee on Judiciary & Labor, I am Walter Yoshimitsu, <u>representing the Hawaii Catholic Conference</u>. The Hawaii Catholic Conference is the public policy voice for the Roman Catholic Church in the State of Hawaii, which under the leadership of Bishop Larry Silva, represents Roman Catholics in Hawaii.

We strongly support the confirmation of Melba Bantay to the Language Access Advisory Council. We truly believe that her excellent background (both personal and professional) will prove to be a great asset to this commission. Her educational background (M.A. in Public Health from U.H. and M. A. in Theology from Maryknoll, School of Theology, Maryknoll, NY) has provided a great foundation for her interest in serving on this commission.

There are several community roles that will directly ensure her active participation on the commission. She is the current Program Director for the Immigration and Refugee Services at Catholic Charities Hawaii. She is currently an active member of St. Theresa Co-Cathedral and has worked in the diocese in several venues that directly impacts the overall community in a positive and constructive way.
