

#### Comments:

I only know Vic Kimura from my representation of union interest in the current Zoning Board of Appeals matter concerning Kyo-ya's proposed Diamond Head Tower development. In that matter, I represent the interests of unionized construction workers in Hawaii, including Pacific Resource Partnership, the Hawaii Ironworkers Stabilization Fund, the Sheet Metal Workers, Local 293, District Council 50, Local 221, Local 1, Local 630, Local 1186, Local 675, Masons and Plasterers Fraternal Association and the Hawaii Laborers-Employers Cooperation and Education Trust, collectively referred to as 20,000 Friends of Labor.

20,000 Friends of Labor intervened in that ZBA proceeding to defend the proposed DHT project. During my representation of 20,000 Friends of Labor in the ZBA matter, I met with Mr. Kimura and many persons who have dealt with Mr. Kimura. I learned that because of Mr. Kimura's leadership position at Kyo-ya, unionized construction workers obtained a collective bargaining agreement that guaranteed retention of unionized labor for the \$300 million DHT project and the companion \$400 million redevelopment of the Princess Kailulani Hotel. I also learned that principally because of Mr. Kimura's leadership, the DHT project properly insures the economic viability of the project and at the same time insures open space, beach access, ocean views from Kalakawa Avenue and sea level rising concerns.

I submit that Mr. Kimura is an excellent candidate for an HTA director position because he has expensive knowledge and experience in the tourism industry, and also understands and embraces the local, Native Hawaiian and environmental values that are necessary to move the tourism industry forward in this important transition phase.

Please understand that I do not and have not represented Kyo-ya.
