Aloha Transportation Committee Chair Souki,

On behalf of over 400 bicyclists in Maui County, we respectfully ask that you support House Bill 1666 - RELATING TO THE PENAL CODE.

The recent death of a young Honolulu Police Department Police Officer, who would be considered a "Vulnerable User" in this measure, highlights the need for additional penalties for drivers who do not, cannot, or will not operate their vehicles in a safe and proper manner on our island roadways.

This bill would help to protect not only first responders like Officer Davis, firefighters and EMS personnel, but many other non motorized users who are at a large disadvantage in any type of collision with a motor vehicle. User groups such as:

- Senior citizens who walk and use transit facilities
- Children who walk or ride their bikes to school or other activities
- Physically challenged individuals who must use personal mobility devices to get around
- Construction and highway workers trying to improve our roadway and other related facilities

all require additional consideration and due care by motor vehicle operators.

The need to protect those individuals who are more vulnerable on the road is not a Hawaii specific issue, but rather a nationwide one as more and more states are recognizing this inequity in our transportation and penal system.

While this bill is the first of its kind in Hawaii, it has already been enacted in Oregon, Washington, Delaware and New York while also being reviewed for enactment in Wisconsin, Florida, California, Connecticut and Michigan.

Please give this bill serious consideration during the hearing on this measure so that all issues can be brought up, discussed and considered for further approval by the many people who would be better protected by this measure.

Thank you for the opportunity to voice our support for this measure we look forward to the Transportation Committee's decision on this matter.

HB1666

This bill addresses the penal code by defining vulnerable roadway users, including pedestrians, cyclists, public safety officers and roadway workers. It further establishes enhanced penalties for drivers who, while committing a traffic offense under the code, seriously injure or kill a vulnerable user legally within the public roadway.

Hawaii's roads are among the most dangerous in the country for pedestrians, cyclists and others who legally make use of the public right of way without being in a motor vehicle. The reason is simple, some drivers are aggressive or negligent, and don't drive safely. When this results in an accident between two motor vehicles, it is often no more than a fender bender; but when it occurs between a motor vehicle and a vulnerable roadway user, it is often catastrophic to the unprotected user.

Many of our State's goals for energy independence, air and water quality, public health and wellness, management of public medical expense, and transportation efficiency are in part dependent on allowing folks to get out of their cars for appropriate length trips, and get about under their own power. These are trips that can be walked or biked, or for which walking or biking connects to a public transit stop. But people will be afraid to get out of their cars if our roadways are not made safer for mixed transportation modes. Driver behavior is critical to this end. Today, harmfully striking a vulnerable roadway user often results in no more than a traffic ticket regardless of the harm done to the victim; HB1666 will apply a fair penalty on those who commit a traffic offence and in the process kill or maim another. It will encourage drivers to take greater care when operating their vehicle n the proximity of vulnerable roadway users. It is fair and just that doing serious harm to another person be penalized commensurately, at least in part, to the harm done.

This bill is a crucial step in making our roadway safer for all. Please give it your support.

Penal Code - Vulnerable Users (OPPOSED)

Aloha Chair and Committee Members,

Thank you for allowing me to provide testimony on HB 1666, which would provide for less punishment in negligent homicide or injury involving the case of motor vehicles when a vulnerable highway user is *not* involved. The best way to illustrate my concerns about this bill is to give an example of what could happen if it passes.

Let's say two car drivers are speeding down a roadway. One driver crashes and hits a pedestrian, killing the pedestrian. The other driver crashes and hits another car, killing the driver. Under this bill, the driver of the car that hit the other vehicle would receive *less punishment* than the driver that hit the pedestrian. How can one justify that the life of the person in the motor vehicle is worth less than the pedestrian?

I oppose this bill because of the inequity it creates and urge you to vote "no."

I am submitting testimony in support of HB 1666, The Vulnerable Users Bill, HB 1666, which provides an extra measure of protection on public roadways for cyclists, pedestrians, first responders and highway workers from dangerous drivers. The reason we need a vulnerable users law is that Hawaii is among the worst in the nation for rates of fatality to cyclists and pedestrians, and negligent and aggressive driving are getting worse. This measure addresses the consequences to drivers from a traffic violation in which a vulnerable user is seriously injured or killed and would educate drivers to be more careful and allow the courts to bring justice for victims and their families.

Some defense attorneys may think it too harsh, but a maimed or killed innocent person is just as ruined from a negligent act as an intentional one, and it is just that the state to act to prevent and punish these acts with a sentence that is balanced with the injury done to the victim. That is what this bill does.

I want tougher penalties for negligent drivers who maim or kill bicyclists, pedestrians, or other vulnerable roadway users. These penalties help reinforce the need to be careful when driving around people who do not have the protection of a car.

Washington, Oregon, and Texas are among other states with similar measures in law; the precedent is well established. Let's join them in holding negligent drivers accountable when they injure or kill pedestrians, bicyclists, and other vulnerable roadway users. I am in favor of HB 1666.
