H.B. 1676 – RELATING TO PUBLIC WORKS

The Hawaii State AFL-CIO strongly supports H.B. 1676 which establishes a preference for the use of American iron, steel, and manufactured goods in the construction, alteration, or repair of public works.

To get our nation back on track we must get our economy working again and working for the middle class. To help ensure this happens, we need to insist our tax dollars are spent at home, on American-made products. H.B. 1676 will do just that. It will help put Americans back to work by ensuring that state tax dollars are used to procure goods made in the United States whenever our trade laws permit.

Unfortunately, since 2000, 4 million U.S. manufacturing jobs have been lost amounting to losses of nearly one-fourth of all U.S. manufacturing jobs. Factory orders now stand at record lows while the U.S. racked up a \$700 billion trade deficit in 2007. However, according to an Alliance for American Manufacturing (AAM) study by the University of Massachusetts' Political Economy Research Institute, significant investment in infrastructure could create more than 250,000 manufacturing jobs if U.S.-made goods are used. This is why it is imperative to pass H.B. 1676. We must do all we can to help keep good paying jobs in the United States.
