I. OVERVIEW OF PROPOSED LEGISLATION

H.B. 1699, H.D. 2 amends the Wage and Hour Law, Chapter 387, Hawaii Revised Statutes ("HRS"), by requiring an employer to provide an unpaid meal break of not less than thirty consecutive minutes if an employee works more than five hours unless a collective bargaining agreement contains express provisions for employee meal breaks.

The Department supports the intent of H.B.1699, H.D. 2, but is concerned about the resources that may be necessary to implement the proposal.

II. CURRENT LAW

Currently, there is no provision in Hawaii's Wage and Hour Law that requires meal breaks.

III. COMMENTS ON THE HOUSE BILL

Neither State nor federal law requires meal or other break periods. The Child Labor law is an exception, requiring at least a 30-minute break for 14 and 15-year-old minors who work five continuous hours.

 Hawaii's Wage and Hour Law applies to small businesses while those businesses who make more than \$500,000 in gross sales per year are subject to the federal Fair Labor Standards Act 29 C.F.R. section 785.19; H.B. 1699, H.D. 2 February 28, 2012 Page 2

which does not require meal breaks.

2. The DLIR is concerned it lacks resources to implement the proposal. Broadening the scope of the law, and requiring additional investigation requirements, will further serve to increase the workload of an already overburdened staff of five investigators statewide who are responsible for conducting more than 600 investigations and responding to more than 20,000 inquiries annually.

Chair Oshiro and Members of this Committee, my name is Max Sword, here on behalf of Outrigger Hotels Hawaii to provide comment in opposition to this bill.

We in the hotel industry operate on a 24/7 schedule and we do not dictate the hours when our customers can arrive and depart. They come and go according to their schedule not ours, hence our concern with this bill.

Dictating when an employee takes his or her meal break, is at times, dictated by our customers. In most cases it should not be too difficult to schedule meal period within the 5 hours but it can be a challenge for properties when our house is full or there are a number of rush check-outs.

If a group of customers arrive at the 5-hour mark of a shift, do we tell them to wait until after lunch before we can clean the room that we just checked out, before we can check them in? Or if a customer comes up to the front desk asking for a room and it is at the 5-hour mark, do we tell them to wait "we are on lunch break"! I do not think that will play well with any of our visitors. Does one think that we will get positive response with this type of rigidity in schedules? This type of negative feedback is what we in the industry work hard to avoid.

If we were a nine to five factory, it may work, but not in an industry which runs 24 hours a day, 365 days a year. Please consider how this bill will affect the number one industry in the state.

Aloha Chair Oshiro, Vice Chair Lee, and members of the committee. We are Ryan Kusumoto and Lisa Kracher, the Legislative Committee co-chairs for the Society for Human Resource Management – Hawaii Chapter ("SHRM Hawaii"). SHRM Hawaii represents nearly 1,000 human resource professionals in the State of Hawaii.

We are writing to respectfully <u>oppose</u> HB 1699, HD2, which requires employers to provide meal breaks for employees and imposes penalties for failure to provide meal breaks.

Human resource professionals are keenly attuned to the needs of employers and employees. We are the frontline professionals responsible for businesses' most valuable asset: human capital. We truly have our employers' and employees' interests at heart. We respectfully oppose this measure for the significant implementation challenges and administrative burden it would impose and for the potential for unintended consequences and costs. Among our most significant concerns are the challenges of implementing the provisions regarding the calculation of overtime payments. We believe that overtime payments may be necessary under this bill due to the potential unintended effect of altering the current Hawaii law on calculating employees' regular rate of pay for overtime purposes. We are reviewing the remaining portions of this bill and, if it advances, request to be a part of the dialog concerning it. Thank you for the opportunity to testify.


Our company already makes breaks and meal breaks of 30 minutes or longer available to our employees. This practice has been in place even without a law to tell us to do so because we understand the benefits of workers to have sufficient rest periods and meal periods.

Having a law to mandate our entire hourly workforce is burdensome, negative, unnecessary and not in the best interest of our workers and our business.

- 1) Burdensome and negative: Managers and supervisors will have to monitor their employees to see that each one is taking a full 30 minute break and taking it before 5 hours of continuous work has passed. Managers will be required to keep records of employees who fail to observe the proper meal break, and they will be required to investigate the reason why the employee did not properly observe the break policy. The manager may be required to impose disciplinary action on those employees who deliberately delay their 30 minute break so as to incur overtime pay.
- 2) <u>Unnecessary</u>: Employees currently have the freedom to take their break and lunch break daily. If they did not take a break it is by mutual agreement between the supervisor/manager and the employee.
- 3) Not in the best interest of our workers and business: Here are some real life scenarios: An employee requests to skip her 30 minute break for a shorter break so she can leave early. An employee requests to shorten his break because he arrived to work late and would like to make up the work hours he missed. An office worker requests to take a lunch break later in the afternoon so that he can go do a personal errand. A merchandiser in a store is in the middle of assisting a customer, so he adjusts his lunch time by a few minutes later so he can finish helping his customer. A production worker is ready to take his 30 minute break, but the worker who is to relieve him is taking an extended lunch break, so he will wait a little longer before taking his break so as not to leave the machines unattended. A delivery truck arrives unexpectedly to offload a container and so our warehouse worker clocks out 5 minutes early from lunch to go receive the delivery. Employees who adjust their lunch periods to accommodate customers and needs of the business do so willingly because they understand the positive impact to our operations. Employees who end up taking a break of less than 30 minutes are being paid for those breaks, as the current law requires.

Such flexibility to accommodate workers while meeting the needs of our business is the optimal arrangement we would like to preserve. Please do not make a law that does not fit our business. We provide employees opportunities to take breaks and we provide them the flexibility to forgo breaks in a responsible manner which is mutually beneficial. If HB1699 is imposed on us, we will have to implement painstaking meal break tracking procedures, prohibit workers from forgoing meal breaks, and have to budget to pay for overtime "penalties". HB1699 is an unnecessary and impractical measure for our business and for our employees.

Chair Oshiro and Members of the Committee:

I am Tim Lyons, President of the Hawaii Business League, a small business organization. We are opposed to this bill based not on its intent but because we believe it is unnecessary.

We are also not opposed to this bill because we think that employees should have to work forever without meal breaks however, we do find that the complaints in this area seem to be almost nonexistent; at least, we have not heard of any.

Secondly, most employers are aware of the fact that employees need periodic breaks from their work and they will accommodate this without requiring employees to work straight through if

for no other reason than productivity is better when employees are in good health and get the proper nourishment.

Construction crews with fifteen (15) minutes more needed to close a job instead of returning the next day, a retail salesperson in the middle of a sales transaction all come to mind as to situations where the employee delaying a break could be essential. To mandate as a requirement, particularly with a one and one half hour penalty provision, not only will work against the employer but we believe in many cases, will work to the employee's disadvantage as well.

We also note that the bill provides that the meal break would not apply if there is a Collective Bargaining Agreement that contains expressed provisions about meal breaks. We believe that this should read instead that this entire bill does not apply where there exists a Collective Bargaining Agreement. It is up to the bargaining parties to address employee meal breaks and this is something that should be negotiated, not mandated.

Based on the above, we do not support this bill.

The Hawaii Food Industry Association opposes this legislation.

HB 1699 requires employers to provide meal breaks for employees and imposes penalties for failure to provide meal breaks. The HFIA believes the Bill is unnecessary and opposes the Bill for the following reasons:

First, the Bill will cause confusion and litigation regarding the calculation of overtime payments due to the unintended effect of altering current law on calculating employees' regular rate of pay for overtime purposes. For example, under FLSA, employers can exclude premium pay given for work on holidays or weekends when calculating the employee's regular rate of pay for overtime purposes. Under Hawaii law, if the bill passes, an employer would have to factor in premium pay in calculating the regular rate because the only method of calculating the regular rate of pay under Hawaii law is to take the total earnings for the period and divide by the number of hours worked.

Second, a meal break, we believe is unnecessary. Most employers already provide meal breaks, and in many cases provide meal breaks longer than 30 minutes.

Third, the bill will hurt employees who would rather work through their lunch or take shorter breaks in order to shorten their work day. Employers who currently operate ten hour shifts would be required to force employees to take an unpaid 30 minute meal break before the fifth and again before the tenth hour of work, thereby prolonging an already long work day.

Fourth, the bill will require employers to carefully monitor employees to ensure that they take meal breaks before 5 continuous hours of work have passed. To avoid paying this penalty, employers will have to send supervisors to every employee's cubicle and work location to make sure that employees have taken lunch breaks on time.

Finally, this bill imposes a significant administrative weight on employers, requiring them to create procedures to record meal breaks and to record whether a person elects to forego a meal break in order to obtain overtime pay. The bill may require employers to revise, rewrite or reprogram their payroll systems to recognize the one-half hour per day overtime allocation.

Hawaii's businesses are in the process of recovering from an economic stagnation. The HFIA firmly believes that the enactment of this mandate at this time will greatly hamper the efforts to revitalize the economic climate. Hawaii's business community is at a critical point -- where any additional mandates could mean the difference between continued existence or bankruptcy. As evidenced by recent media accounts, many local establishments, some of which have faithfully served consumers for generations, are going out of business.

Overall, this bill will significantly increase the cost of doing business in Hawaii. For these reasons, the HFIA opposes this measure. Thank you very much for the opportunity to testify.

STATEMENT OF THE ILWU LOCAL 142 ON H.B. 1699, HD2 RELATING TO LABOR

The ILWU Local 142 supports H.B. 1699, HD2, which requires employers to provide meal breaks for employees who work more than a total of five hours a day, imposes penalties for violations, and clarifies that the penalty is based on an employee's regular wage at the time the infraction occurred.

Meals breaks offer not only opportunities for workers to get nourishment during the day, but allow workers uninterrupted periods of rest to recharge and sustain them through the remainder of the work day. Offering meal breaks to all workers is a humane way to treat employees and sensible to foster concentration, productivity, and fewer accidents.

There are provisions in most, if not all, collective bargaining agreements for a meal break. In those agreements, there are also provisions for payment of additional wages if a meal break is not provided. Aloha Chair Oshiro and Vice Chair Lee, members of the Committee, I apologize for not being present to provide this testimony. I own and operate a retail ice cream shop and must be manning the counter at this time; however, I would like to express that I know that I am in a similar position to many small local retail establishments and that passage of this bill will present scheduling choices, none of which are beneficial to my business or to my employees.

I own an ice cream shop in East Oahu and typically run a one or two person operation; scheduling around days and times I know will be busy and profitable. My employees are generally part time workers. Many hours of the day are filled with unprofitable time...a specific example is on Tuesdays...Hanauma Bay is closed and business is slower. I or my employees work from 9:00 AM to 5 PM without a "scheduled" break. However, we do have ample time to eat and take care of our personal needs. My employees are in college and are encouraged to do their homework as well. If this law were to be implemented, I believe, that I would have to bring in a second person for a break at 2:00 PM...that being said, I will have to reduce the hours of this employee to five hours this day because I cannot afford to have two employees on during this time. This will have an adverse affect on my employees financial situation and may result in prolonging her college years.

There are many other situations where we employers will find it either impossible or much more expensive to comply with this law. Can you imagine a security company's dilemma for the mid shift...call someone in at 3 in the morning for a half hour break.

Please hold HB1699 and preserve local businesses.

As a small business, It will be difficult to administer and will impose additional costs in running my business. I'm already operating on slim margins through increased unemployment tax (\$400 in 2009 to \$15,000 in 2011) and rents that have risen by 20%.

I take care of my employees by providing benefits and other accommodations as many of my employees have been with me for a long time (the longest being 45 years). I am writing in opposition to HB 1699 requiring mandatory meal breaks for employees working 5 hours or more. Maui Economic Opportunity, Inc. is a private nonprofit Community Action Agency. We administer over 60 various

programs, each with funding limitations and restrictions. As a

nonprofit, passage of this law will place an undue burden on our Head Start Preschool program which requires that the children eat family style meals with the staff. The staff members are paid to eat with the children and are able to finish their day earlier than they would if they were required to take a meal break after 5 hours. Due to licensing we are required to have two staff with the children at all times. This law would require us to hire additional staff to cover the meal breaks. We serve over 300 children and families in 15 different centers throughout Maui County, making it impossible to hire only one or two staff to cover the meal breaks. With funding being so tight, if this bill passes will would be required to reduce the number of children and families served in order to be compliant with the law. For all other employees, our personnel policies allow for an unpaid 45 meal break. In many cases staff members prefer to forego their meal break so they can flex their time to accommodate child or eldercare obligations.

Please do not pass this Bill into law.
