PURPOSE: The purpose of H.B. 1735, H.D.1 is to establish the Hawaii Interagency Council on Homelessness under the Department of Human Services for administrative purposes. This bill also requires the Department of Human Services to conduct a study on establishing safe havens in the State and to submit a report to the Legislature prior to the 2013 Regular Session on its findings and recommendations from the study.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports the intent of this bill to establish the Hawaii Interagency Council on Homelessness (HICH). The DHS, however, requests that the Legislature consider Administration bill, H.B. 2542 to establish the Hawaii Interagency Council on Homelessness.

H.B. 2542 would establish the HICH by statute. Statutory enactment will enhance the ability of the council to provide solutions for ending homelessness, by highlight the importance of ending homelessness, and strengthen continuity through future administrations. The recommended membership of the Council, with the exception of the Department of Hawaiian Home Lands (DHHL) which we concur should be included as a member of the HICH, is also detailed in H.B. 2542. We will request that the DHHL also be included in the membership of the HICH. In addition, the representative of the Hawaii Public Housing Authority should be designated by the Executive Director of the HPHA, which is attached to the DHS for administrative purposes.

The Department respectfully requests that the provision requiring the DHS to conduct a study of the feasibility of establishing safe havens for people who are homeless across the State be reconsidered. The U.S. Department of Housing and Urban Development (HUD) which is the national leader in addressing homelessness, has been encouraging Hawaii and other communities across the country to prioritize greater resources on permanent (and supportive) housing, and decrease our reliance on emergency and other temporary shelter programs. The DHS is concerned that diverting limited existing funding to explore the feasibility of additional emergency programs will not bring us closer to a solution to homelessness. If the feasibility study is mandated, the DHS respectfully recommends that the term "safe haven" (as used in SECTION 7) be replaced with "safe zones/areas" because a program called Safe Haven (which provides transitional housing to mentally ill homeless persons) already exists on Oahu. The revised wording will hopefully prevent this existing program from being confused with the proposed legislation.

Thank you for the opportunity to provide comments on this proposed legislation.

#### Re: H.B. No. 1735 HD1 Relating to the Homeless

#### I. OVERVIEW OF PROPOSED LEGISLATION

- The proposed legislation seeks to establish the Hawaii interagency council ("Council") on homelessness, an advisory body exempt from Section 26-34, HRS, and administratively attached to the Department of Human Services.
- The Council shall formulate and coordinate a unified plan in all counties, and acquire federal funding for homeless programs.
- The Council shall be composed of representatives from different state agencies.

#### II. CURRENT LAW

We defer to the Department of Human Services regarding current laws on this subject.

#### III. COMMENTS ON H.B. NO. 1735 HD1

- The Department of Labor and Industrial Relations (department) supports an integrated approach to addressing homelessness as proposed by this measure as long as its passage does not displace the funding priorities of the administration.
- DLIR requests that the representative of the department be at the discretion of the director (and not necessarily restricted to the Workforce Development Division as proposed) because more than one office/division in the department works with the homeless population.

This collective group maintains key oversight of federal Super Notice of Funding Availability (NOFA) funding that is awarded to rural county organizations that serve the homeless population.

Chair Oshiro, Vice Chair Lee, and Members of the Committee on Finance:

Thank you for the opportunity to submit written testimony with amendments on behalf of HB 1735, which establishes the Hawaii Interagency Council on Homelessness. My name is Gladys Peraro, Advocacy Chair, Partners In Care (PIC). Our coalition focuses on the needs of homeless persons and strategies to end homelessness. Partners In Care supports the creation of an Interagency Council on Homelessness as an important strategy in utilizing the State's resources to end homelessness.

As one of the Members of the Council named in this bill, Partners in Care is eager to participate in the Council to actively identify and implement solutions to homelessness. A collaborative effort is indeed needed to decrease the growing number of homeless persons in Hawaii. Only through a coordinated and concerted effort will we realize an end to homelessness in Hawaii. The diverse group of entities and agencies from the State, County and other entities across Hawaii will bring the strength needed for the Hawaii Interagency Council on Homelessness to make a difference. Additionally, representation from homeless services providers such as the members of PIC and other homeless coalitions (Continuums of Care), faith based organizations, and the like will have the reatest effect as we work together to effect meaningful change for this social problem. The Council has already begun its work and is identifying critical strategic goals and initiatives that would prevent homelessness as well as ensure that homeless persons obtain permanent housing and become reintegrated into the community. Establishing the Council by statute, will further augment the Council's ability to implement solutions for homelessness and ensure continuity as administrations change.

#### **Suggested Amendments:**

- 1) We implore the Legislature to ensure that any administrative costs for the Council not impact on direct service funding to homeless programs already established. Additional funding would need to be appropriated for the expenses of this Council.
- 2) In Section seven (7), we suggest that the wording be changed from "safe havens" to "safe zones/areas". There is already a Safe Haven program in Honolulu, which provides transitional housing to mentally ill homeless persons. This amendment will ensure that the program not be confused with the bill, which is to study "tent city" type programs.

Thank you for your support as we work together to realize solutions to end the crisis in homelessness.
