Please support HB 1755 HD2 SD1 to make voter registration more easily available to residents of Hawaii by setting aside the funds and establishing a system that allows for a modernized online voter registration application. The fact that Hawaii is among the lowest voter registration rates of the country, approximately 59%, compared to the national average of 71%, (2008 U.S. Census Bureau), fails the principals democracy. Hawaii being among the states with the lowest voter turn-out rates at approximately 52% compared to the national average of 65%, (2008 U.S. Census Bureau), needs to decrease the amount barriers for the average citizen to register to vote and desperately increase registration convenience.

HB 1755 HD2 SD1 creates an optional and more convenient application that requires the applicant to provide the same information as the current system of registration and is principally similar in content. The option also includes making registration increasingly efficient by exempting a citizen from having to physically deliver paperwork that currently exists within the governments database. Furthermore, studies show that online registration saves money in the long run by reducing costs of paper registration forms.

Voting is the pillar of which the United States democracy stands. It is crucial that the State of Hawaii increase its democratic participation so that all of Hawaii's citizens are fairly represented. Voter registration is the first step to increasing political engagement and allowing for the establishment of modernized online option to register is an obvious answer. # TESTIMONY Nikki Love, Executive Director, Common Cause Hawaii

Chair Ige, Vice Chair Kidani, and Committee Members:

Common Cause Hawaii supports HB1755 HD2 SD1. This bill allows for the establishment of online voter registration, and appropriates an unspecified amount of funds to create and implement the system.

We support this effort to modernize voter registration for the 21st century and reduce barriers to voting. Hawaii has been consistently at or near the bottom of all 50 states in voter turnout, and every effort should be made to encourage eligible citizens to participate. The numbers from the 2010 General Election show that there an estimated 961,213 eligible voters in Hawaii, but only 690,748 registered voters. This leaves an estimated 270,465 potential voters -- 28% of those eligible -- who were not registered at the time of the 2010 General Election. Online voter registration can make participation in our democratic process more accessible and convenient. Furthermore, an online system could be used for existing voters to update their registration after moving residences.

Online voter registration can also provide greater accuracy in the voter rolls and save significant money in the long term, by streamlining the process and reducing the burden of data entry. A study by the Pew Center on the States showed that in Arizona, it costs an average of three cents to process an online application compared to an average of 83 cents per paper application; in Washington, the state saves 25 cents per online application (continued on next page...)

and counties save between 50 cents and \$2.00 per online application compared to paper forms. ii

We ask the WAM Committee to find the necessary funds to implement online voter registration. Last year we researched the costs of implementation in other states, and found that startup costs ranged from \$120,000 to \$245,000 in Oregon, Colorado, and Maryland.

We urge the Committee to move this measure forward, and include an effective date that ensures that the system can be ready for use by the 2014 elections, if at all possible.
