My dental practice provides crucial and necessary dental services to the residents of Kauai. I am one of only a few practitioners in Lihue offering treatment to children and adults on Medicaid (i.e. Aloha Care, HMSA Quest). As a small business/practice owner I employ nine full-time and part-time employees (hiring two last year and one this year) offering benefits including a 401(k) profit sharing plan. Keeping the tax schedule at current levels will allow me to retain staffing

levels for at least one year. I would like to continue to grow my practice but ANY increase in taxes will cripple my ability to hire staff and more likely result in staff reductions. The domino effect is obvious. First, employees file for state unemployment benefits, resulting in higher costs and burden to the state. Second, my practice is forced to reduce dental services to residents of Kauai, resulting in patients seeking treatment at the already overburdened state clinics in Kapaa and Waimea. Third, these clinics routinely refer patients to dentists on Oahu for treatment. Finally, this means the State of Hawaii is now burdened with paying for inter-island airfare, taxi costs to and from the airport and the dentist's office for the patient and their family members, and the cost of dental treatment.



My name is Forrest Koa Chang, the General Manager of Ali'i Kula Lavender in Upcountry Maui. I appreciate the efforts made by the chair and the committee in addressing the unemployment insurance tax increase.

I support HB 2096, however, due to the tough economic times, maintaining the same tax level for two years is preferable for the following reasons:

Based off of the proposed increase and our number of employees, our excess wages will rise by \$4,600.00 quarterly (\$18,400 annually). This will, in turn, inflate our net excess wages significantly, our contribution rate would spike and we would experience increases in the amount we owe for contributions due, as well. While we already face considerable challenges doing business in Hawaii, increases in unemployment insurance tax will surely diminish our ability to meet the everyday hardships of increased costs in transportation, increased costs of product components, lessened spending on the part of customers and the resulting heightened competition among retailers and agribusinesses, such as ours.

A two-year deferment would plainly provide our business with greater opportunity to stabilize and recover. 2011 has proven to be a very challenging year for our company and has led to various reorganizations and many cutbacks already. Increasing Unemployment Insurance Tax at the present moment will very likely accomplish what our State would like to avoid: more layoffs and more dependency. It is my opinion that introducing new hardship to employers in 2012 will adversely impact our local economy in more ways than will benefit our community.
