My name is Dave Arakawa, and I am the Executive Director of the Land Use Research Foundation of Hawaii (LURF), a private, non-profit research and trade association whose members include major Hawaii landowners, developers and a utility company. One of LURF's missions is to advocate for reasonable, rational and equitable land use planning, legislation and regulations that encourage well-planned economic growth and development, while safeguarding Hawaii's significant natural and cultural resources and public health and safety.

LURF appreciates the opportunity to express its **support of HB 2363** and of the various agricultural stakeholder groups who defend the goals of viable agricultural operations, and the conservation and protection of agriculture, including important agricultural lands (IAL) in Hawaii.

HB 2363. This bill requires the convening of a task force to conduct a study as to whether an agribusiness cooperative program to promote the distribution of local farm products to large retailers, should be established in Hawaii.

LURF's Position. In view of the difficulty currently experienced by local farmers to distribute their products to large retail establishments, LURF supports the convening of a task force by the Department of Agriculture to conduct a study to determine the feasibility of an agribusiness cooperative program intended to assist the farmers to increase distribution of local products, and to develop feed mills to lower farm expenses and minimize carbon impact as a result of transporting feed imports. LURF especially concurs with the intent of the bill to explore means by which the program may be permanently funded through private and public resources.

Despite high productivity by local farmers, limitations on the distribution of local products is not only discouraging to farmers, but prevents the State from meeting its sustainability goals for food production.

Based on the above, LURF **supports HB 2363**, and respectfully urges your favorable consideration of the bill.
