## RELATING TO THE INFORMATION PRIVACY AND SECURITY COUNCIL

Chair Keith-Aragan, Vice Chair Rhoads, and members of the committee, thank you for the opportunity to testify on H.B. 2436.

The Office of Information Management and Technology supports the overall intent of the H.B. 2536. At this time, we would like to recommend that the comptroller be replaced by the chief information officer as the chair of the council.

When the Information Privacy and Security Council was first established the state did not yet have a full-time chief information officer (CIO) to provide the overall direction and vision for information technology (IT). Hawaii Revised Statutes §27-43 establishes the role, responsibilities and authorities of the chief information office. As information security and privacy fall under the purview of the CIO and are being addressed in the information technology strategic plan that is currently under development, naming the CIO as chair will be align the council to the state's IT strategic vision.
