Aloha Chair Hanohano, Vice Chair Lee and Members of the Committee,

Thank you for the opportunity to testify in support of HB 2529. This bill exempts expenditures less than \$250,000 from Hawaiian Homes Trust funds identified in the Hawaiian Homes Commission Act, 1920 as amended, Section 213(d) from the requirements of Chapter 103D, HRS.

The Hawaiian Homes Trust and its lands has a special designation within the Hawaii State Admissions Act, Section 4. This special designation should permit the Department of Hawaiian Home Lands (the Department) to be exempted from state procurement laws, regardless of amount, simply because the Department currently operates without the support of general funds from the State and is totally dependent upon its trust fund resources. However, if exempted from Chapter 103D, the Department must have its own stringent procurement policies in place in the interest of transparency and accountability. Further, expenses would be regulated and monitored by the Hawaiian Homes Commission.

Precedence of being exempt from state procurement laws have been set and put in place by the University of Hawaii. It is only fair and right that the Native Hawaiian beneficiaries, through the Department of Hawaiian Home Lands be afforded this same exemption.

We support HB 2529.
