Chair Keith-Agaran, Vice Chair Rhoads and Committee members:

I am Victor Gustafson, Interim Vice Director for Civil Defense, State Department of Defense. I am providing written testimony in support of House Bill 2686 because it will aide in our private sheltering and community preparedness initiatives.

State Civil Defense plans for 35% of Hawaii's population to evacuate to shelters in an emergency. Based on that planning assumption, our statewide public shelter program is approximately 74,000 spaces short. We are currently pursuing alternatives to make up this shortage, including inspection of private buildings (e.g., hotels, condominiums) to serve as shelters. HB 2686 would give building owners an incentive to open their facilities to people seeking shelter in an emergency and would help relieve the burden on the State.

HB 2686 would also provide limited protection to organizations willing to work with community volunteers in an emergency. This could be especially helpful in pre-staging equipment, which would enable faster response to disaster stricken areas.

Thank you for the opportunity to provide written testimony that supports this bill.



Emergency Shelter; Private Property Owner; Limited Liability

Good Afternoon Chair Keith-Agaran, Vice Chair Rhoads, and members of the Committee on Judiciary.

My name is Claudine Tomasa - Kailua resident - and I am testifying in support of HB 2686 which exempts the owners of private property from liability for injury, death, loss, or damages suffered by a person who was allowed on the premises due to an emergency by the owner of the property or by an agent of the owner of the private property; unless it was intentionally inflicted or occurred by the gross negligence of the private property owner/agent of the owner.

We have been informed by Government Agencies (Hawaii State Civil Defense and the City & County of Honolulu's Department of Emergency Management) as well as by private agencies (American Red Cross – Hawaii Chapter) that there are not enough Emergency Shelters to accommodate evacuees during a disaster.

However, private property owners (i.e. of shopping centers, faith based groups/churches, etc) are willing to work together with the aforementioned agencies; and offer their premises as shelter should an emergency or disaster occur – if they are legally protected. I believe that HB 2686 will provide these owners protection from potential civil liability.

I also believe that HB 2686 will also assure the availability of more future emergency shelters for our people should any type of disaster strike our islands (i.e. hurricane, flooding, tsunami, etc.). It is for the above reasons that I urge you to pass HB 2686 out of Committee.
