TESTIMONY IN SUPPORT OF HOUSE BILL 309 H.D.1

Relating to Housing Submitted by Nani Medeiros, Co-Founder, Hawai'i Housing Alliance February 16, 2011, 10:00 a.m., Conference Room 325

The Hawai'i Housing Alliance supports House Bill 309 House Draft 1. This bill provides a mechanism to address affordable housing needs in the City and County of Honolulu using a targeted density incentive for a corridor bound by Kapiolani Blvd., South Beretania Street, South Street, and Kalakaua Avenue. Density incentives have been suggested for decades in Hawai'i as a way to provide housing for our workers and has received support at both city and state levels of government as a tool. Honolulu's city council passed a resolution, introduced by former Councilmember Charles Djou, urging the city building permit department to allow more flexible height limits in Honolulu's urban core.

Increasing density in the urban core to provide affordable housing prevents urban sprawl, encourages the use of public or pedestrian transportation, decreases the traffic burden on roads, and improves workers' quality of life.
