TESTIMONY OF ROBERT TOYOFUKU ON BEHALF OF THE HAWAII ASSOCIATION FOR JUSTICE (HAJ) IN OPPOSITION TO H.B. NO. 679, HD 1

April 2, 2012

To: Chairman Clayton Hee and Members of the Senate Committee on Judiciary and Labor:

My name is Bob Toyofuku and I am presenting this testimony on behalf of the Hawaii Association for Justice (HAJ) in OPPOSITION to H.B. No. 679, HD 1, relating to Firearms.

It is unclear what this measure seeks to accomplish and why it is needed. The language of the original bill suggests that its intent is to encourage NRA certified instructors to provide gun training required to obtain a handgun permit by exempting certified instructors from the liability currently found in HRS section 663-9.5. However, the reason that this exemption is required or desirable is not clear.

The liability of gun owners found in section 663-9.5 was codified in 1994. There has not been a single instance where an NRA certified trainer has been held liable under section 663-9.5 during the almost 20 year existence of the section. There is no reasonable basis to believe that there is any need to make the sweeping exemption proposed in this measure. Firearms are extremely dangerous and require the highest care in their handling and use. This section serves to encourage safe handling of firearms. NRA certified trainers possess the highest degree of knowledge, skill and care in the safe handling of firearms such that the proposed exception should not be required. The fact that no NRA certified trainer has ever been subject to liability under section 663-9.5

shows that the exemption is unnecessary for firearms courses properly taught by NRA certified trainers.

Under 663-9.5 the gun owner is only liable for his/her own shooting of the weapon and is not liable if others shoot the gun. So in a gun training class the NRA certified trainer would only be liable if he/she shot someone. The NRA trainer is not liable under 663-9.5 if the person being trained shoots another person with a gun provided by the trainer or brought by the trainee. In other words, if the NRA certified trainer brings extra guns for trainees to use during the training session, the trainer is not liable for the trainee's use of the gun under 663-9.5(b)(1) because **liability when the gun is not in the possession of the owner is specifically exempted**. Similarly, the trainer is not liable when the trainee brings and uses their own gun because 663-9.5(a) only applies to the trainer's own gun. Since the trainer is only liable under the statute if he/she shoots someone, and would be liable under other principles of law anyway, the exemption makes no difference and only creates an ambiguity and confusion whether this amendment is intended to provide an NRA certified trainer with immunity from his/her own shooting of another individual.

If there are specific circumstances related to NRA certified training sessions that merit exceptions to an owner's responsibility to properly handle their weapons, these circumstances should be addressed specifically and dealt with narrowly rather than with a broad and complete exemption from liability.

However, if this committee decides to pass this measure forward, we suggest amending the HD 1 by substituting the following language in place of the provision on page 2, lines 15 to 22 and page 3, lines 1 and 2 in the HD 1:

f) Where a National Rifle Association certified firearms instructor provides firearms for training or safety courses or classes at a firing range or other firearms training facility to persons seeking to acquire a permit for the acquisition of a pistol or revolver in accordance with section 134-2(g)(4), the absolute liability under subsection (a) shall not apply to the National Rifle Association certified instructor for the use of the instructor's firearms by persons participating in such training or safety courses or classes; provided that this section shall not be construed to relieve a National Rifle Association certified firearms instructor from any other tort liability that may be applicable.

Hon. Chair, Co-Chair, Members,

HRA strongly supports this bill. The NRA Certified Instructors in HI should have this protection from "absolute" civil liability. They provide their own personal firearms for the public to use to obtain safety training per HRS 134-2(g) (4), a pre-requisite for obtaining a permit to acquire a handgun.

There is a precedent. HRS §663-9.5 (d) was amended in 2008, exempting the counties from absolute liability when an enforcement officer uses his gun "outside of the course and scope of employment as a law enforcement officer" showing that the counties were worried about government liability for a police officer's gun when he was in possession, because the gun is owned by the county. The amendment was presented by former Senate Judiciary Chair Andy Levine, representing the Maui Mayor's office, after an off duty Maui Police Officer used his duty pistol to murder his wife. The plaintiffs bar supported the amendment.

The owner is "absolutely liable" and can only raise an affirmative defense that the firearm was not in his possession. This means that at the very least an instructor could be forced to go to court to make the argument that he didn't possess the gun. In many cases, that argument would fail because the law recognizes the possibility of constructive possession without direct physical control. The Hawaii courts frequently cite Black's Law Dictionary:

"A person who knowingly has direct physical control over a thing at a given time is then in actual possession of it. A person who, although not in actual possession, knowingly has both the power and the intention at a given time to exercise dominion over a thing, either directly or through another person or persons, is then in constructive possession of it." State v. Taylor, 2011 WL 6376646, *25 (Haw.2011)

In an NRA class where the instructor is at no more than arms length from any student with a loaded firearm and directing the student as to exactly what to do with the guns at any given time, an instructor certainly could be held to be in constructive possession of the guns he or she owns and has furnished.

This bill does not make it impossible to sue instructors teaching these classes. While the bill would relieve them of the special absolute liability created by sec. 663-9.5, they could still be sued in ordinary actions for negligence.

The current absolute liability is just that, absolute, and our dedicated Instructors need relief from it. Please pass this bill out as is.

Testimony in Support of HB 679

Good Morning Chair Hee and members of the Judiciary Committee.

My name is Bill Richter and I am the President of Lessons In Firearms Education (LIFE), a notfor-profit organization committed to providing quality firearms training for Hawaii's citizens. LIFE has trained thousands of individuals over the years and is likely the oldest firearm training organization in Hawaii.

I am testifying in support of HB 679.

As a volunteer organization, LIFE relies on our volunteer instructors in order to continue our mission. Without adequate volunteer instructors, our ability to provide the needed training would be severely hampered. Many of our current instructors, and others who would like to become instructors, have expressed concern over the issue of liability. LIFE, and other training organizations, must, because of Hawaii's laws, use their personal firearms for the classes. Passing HB 679 would allow them to focus on training, rather than liability concerns.

And, while I would ask you to pass HB 679, I would like to also ask you to consider amending the language to address some issues. First, the language of the bill states that only training provided at a "...range, or other firearms training facility..." would be covered under this bill. Since many instructors, including LIFE, provide non-firing portions of training at other locations, like private homes, offices, or meeting rooms, excluding this locations greatly limits where "covered" training could take place.

Second, the language seems to exempt only that training necessary to obtain a permit to acquire a handgun. Since the training necessary to meet the statutory requirements to obtain a permit to acquire is necessarily basic, we always recommend that students continue their training and to practice their newly obtained skills. This is essential to maintain their proficiency and to promote continued safe firearms handling. Since the effort with this bill is to promote safe firearm handling thru education, I am sure this committee's intent is not to inhibit this additional and ongoing training that ultimately results in safer gun owners.

I would respectfully ask that the committee make amendments to the bill to address these issues, and to then pass it out.

PLEASE PASS HB679..

Good Afternoon Chair Hee and Vice-Chair Shimabukuro.

I support H.B. 679, H.D. 1, and am asking you and the committee members to support and pass this bill. I am an NRA certified instructor and volunteer as an instructor for Lessons In Firearms Education (LIFE). As an NRA certified instructor who provides the use of my personal firearms to students during State mandated firearms training, I am concerned that I may be liable should, despite adhering to best practices in providing a safe training environment, a student cause injury or property damage with my firearm. This concern over liability has caused me to reconsider if I can continue providing this training and I know other instructors that are equally concerned. I understand that the State and Counties asked for, and received, the very same exemption from liability that this bill would provide to NRA instructors. It seems only fair and reasonable that we should receive this same level of immunity.

I also understand that the group representing lawyers who profit from liability litigation are of the opinion that current language of the law already provides sufficient immunity for instructors. But, I would ask that you consider that opinion as extremely biased. Obviously the lawyers for the State and Counties believed they had too much liability exposure, as did the legislators who passed the bill exempting them. So, why would you believe that NRA instructors, operating under the same conditions are somehow different? The truth is that there is no difference. We have the same level of liability exposure and deserve the same immunity so we can continue providing this vital community service.

I would also ask that you remove the limitation to classes "to persons seeking to acquire a permit for the acquisition of a pistol or revolver in accordance with Section 134-2(g)(4)." While other classes may not be required by law to obtain a pistol, they should still be covered. The exemption given to the State or counties for use of firearms is not limited and I believe the exemption for NRA instructors should not be limited either. In order to become a firearms instructor, an individual must pass a course. The instructor of an instructor's course would not have limited liability, but the course is necessary to ensure citizens are able to meet the State requirements to purchase a handgun, and thus it is necessary to have instructors for the course. If individuals are not able to be certified as an instructor because of the fears of the liability issue, then citizens have a more difficult time meeting the State's requirements for a handgun purchase.

Please support and pass H.B. 679 HD1, with an amendment to remove the limitation of coverage.
