TESTIMONY ON HOUSE CONCURRENT RESOLUTION NO. 141, REQUESTING THE DIRECTOR OF COMMERCE AND CONSUMER AFFAIRS TO CONVENE A TASK FORCE ON DOG BREEDING.

TO THE HONORABLE KYLE T. YAMASHITA, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Keali'i Lopez, Director of the Department of Commerce and Consumer Affairs ("DCCA"). Thank you for the opportunity to offer comments on House Concurrent Resolution No. 141, which requests the Director of DCCA to convene a task force on dog breeding.

While the DCCA supports the intent of the resolution and the prevention of animal cruelty, the DCCA does not feel that it is the appropriate agency to convene such a task force. It does not have the wisdom or expertise on how best to prevent instances of animal cruelty by large-scale dog breeders. A majority of the bills relating to dog breeding that were introduced this session appropriately places its regulation under the purview of criminal law enforcement or county licensing agencies. Therefore,

we are recommending that the task force be overseen by an entity with expertise in law enforcement or animal control.

The American Kennel Club (AKC) writes in support of House Concurrent Resolution 141 and respectfully requests that members of the House Committee on Legislative Management pass this measure.

We wish to thank Representative McKelvey and the sponsors of HCR141 for their commitment to preventing dogs from being maintained in inhumane conditions, while also recognizing that residents of Hawaii have the right to purchase healthy dogs raised by responsible, local breeders.

The AKC sent letters of strong concern regarding bills introduced in the 2011-2012 sessions that contain provisions detrimental to the welfare of dogs and that would consider every owner of ten intact dogs to be a "large scale breeding facility," even if the person breeds no litters and sells no puppies. By including experienced, responsible breeders on a dog breeding task force, it is hoped that these and other problematic provisions will not appear in future measures.

Comments:

My name is Kaye Walsh, President of the Cavalier King Charles Spaniel Club of Hawaii, representing over 100 statewide owners of Cavalier King Charles Spaniels, a small family companion dog. We ask you to pass HCR141 to establish a task force of LOCAL people who can investigate the true situation regarding dog breeding in Hawaii, not mainland organizations and paid lobbyists with agendas of their own which will in the long run completely outlaw the purposeful breeding of dogs with known qualities.

I polled the members of my club, breeders and owners of neutered pets alike. Not one of our breeders or owners was contacted by the two groups (HSUS and HHS) promoting legislation such as HB108 and SB2492 which place onerous regulation on hobby breeders of purebred dogs and catches them in the same net as large scale commercial breeders.

The very few large scale commercial breeders or hoarders are not the only issue. I have been involved in Cavalier rescue for many years and have taken in dogs imported from Australia which had horrendous medical problems sold from the now closed Pet Central. They weren't breeding themselves, but purchasing from questionable breeders, so the breeding sections of the legislation wouldn't apply to them. I have also rescued Cavaliers from ONE individual who owned and bred only two Cavaliers for years until the female was paralyzed and living in her own filth.

I did some online research myself to determine where the thousands of dogs come from mentioned in the preamble to these bills and found that Cavaliers are being sold online by individual people, almost every one with a different name and different telephone number, so these are most likely one litter amateur breeders, not those interested in the long term betterment of their breed and those types of sellers would not be covered by those bills. However, there is an ad by a person that I am aware of and have reported to HHS, who is advertising a five year old female and a Tri male for sale for \$300. These are most likely his older breeding dogs and he wants to dump them. I don't believe he has ten intact dogs, so the proposed legislation won't trap him, but something should. Some of our members looked at his dogs to purchase and were appalled by the conditions.

Please pass HCR141, our Cavaliers thank you for your attention.

On behalf of the Hawai'i Hulacat Club, a component member of the Cat Fanciers Association, Inc. ("CFA"), the world's largest registry of pedigreed cats, I submit this written testimony in <u>support</u> of HCR 141. Thank you in advance for considering our club members' viewpoints. Although HCR 141 as drafted would apply only to dog breeders, sellers and owners, we are concerned for the welfare of <u>all</u> companion animals as well as their breeders and owners.

CFA is a non-profit organization established in 1906. Over the years, CFA has registered over a million pedigreed cats. The association has over 600 member clubs and annually licenses approximately 400 cat shows worldwide. I have conferred with Ms. Joan Miller and Mr. George Eigenhauser, the chairperson of CFA's Legislative Committee and CFA's Legislative Coordinator, respectively, and have confirmed that CFA as an international organization also supports HCR 141.

Several other currently pending legislative bills — most notably, HB 108 H.D. 1 S.D.1 Proposed — would attempt to prevent inhumane treatment of companion animals by imposing onerous and unreasonable "top-down" regulations upon responsible breeders as well as upon large commercial breeders. In contrast, HCR 141 provides for the creation of a task force composed of a broad spectrum of real-life stakeholders who are knowledgeable on the issues and familiar with the day-to-day concerns of animal breeders and owners. HCR 141 provides a vehicle for legislators to "do something" that is meaningful and actually promotes animal welfare, without having to support misguided legislation that only promises to result in many harmful unintended consequences.

The overwhelming majority of Hawai'i's breeders of pedigreed companion animals are responsible and committed to protecting their animals' health and well-being. The deplorable conditions found at the rare exceptions (such as the infamous Waimanalo "puppy mill") do not justify imposing unnecessary and draconian regulations on the responsible majority of breeders. The task force created under HCR 141 would have the expertise needed to fashion reasonable policies and regulations that solve real problems without imposing unreasonable restrictions on responsible pet breeders, sellers and owners.

All proposed legislation seeking to improve the quality of life and care of companion animals should focus on promoting responsible ownership and on strict enforcement of *existing* animal neglect and cruelty laws — laws passed in years past at both the state and federal levels. Those existing laws have already established reasonable standards of care — but, sadly, they have not been effectively or consistently enforced. Had these existing laws been enforced, the tragedy of the Waimanalo puppy mill could have been averted.

CFA has extensive knowledge and resources regarding companion animal welfare and related legislation. CFA's experienced legislative committee members stand ready to share those resources with the task force created under HCR 141.

We urge that HCR 141 be adopted. Thank you again for your attention and consideration.

HOUSE COMMITTEE ON LEGISLATIVE MANAGEMENT

The Hawaiian Kennel Club has been and remains steadfastly opposed to gratuitous animal cruelty and has been a supporter of the Hawaiian Humane Society for years.

We have been adamantly opposed to several bills introduced this session ostensibly to address animal cruelty, including but not limited to SB2492, SB2494 and their various iterations. Moreover, the Hawaiian Kennel Club and its members have expressed their legitimate concerns regarding these proposed legislative measures in written and oral testimony as members of a free and open society. None of these measures address animal cruelty, but are an attempt to end-run the Auditor's Sunrise Analysis: Regulation of Large-Scale Dog Breeders and Facilities, Report 11-02. This resolution supports the auditor's second recommendation.

- 1. As proposed Senate Bill No. 1522, Senate Draft 2, House Draft 1 of the 2011 legislative session should not be enacted.
- 2. The Legislature should address flaws in the proposed regulation and consider alternatives to licensing by the Department of Commerce and Consumer Affairs to achieve the goal of protecting dogs. Improvements should be done in consultation with stakeholders, including enforcement officials, potential overseeing agencies, veterinarians, and breeders.
- 3. The Legislature should require the proponents of the large-scale dog breeder regulation to provide the number of likely licensees. Doing so will help determine if regulation can be paid for through licensing fees.

Furthermore, the Hawaiian Kennel Club welcomes the opportunity to support the intent and urges the **adoption of HCR 141 as originally submitted and without amendments**, Requesting the Director of Commerce to convene a Task Force on Dog Breeding and looks forward to sustaining and augmenting those proposals that address animal cruelty and the public interest in purchasing healthy dogs.

Chair, Senator Clayton Hee, Vice Chair, Senator Maile L. Shimabukuro. Committee Members, Senator Mike Gabbard, Senator Les Ihara, Jr., and Senator Sam Sloan.

I oppose this legislation AGAIN, and here's why:

It still ignores constitutional provisions on <u>probable cause</u> (especially Section 4 subsection 143) and <u>due process.</u>

Merriam Webster (an authoritative and recognized lexicon) has not redefined dog breeder to mean anyone who owns 10 intact, adult dogs.

I still don't know who died and put the legislature in charge of making veterinarians the final arbiters on which dogs, if any, should be bred. Are they going to be willing to assume this decision-making responsibility and its consequences?

The auditor's report last year recommended alternatives to licensing breeders given lack of information on how much licensing and cost of monitoring/enforcing would be and the paucity of possible licensees. Has she recanted?

The title is a misnomer; it still doesn't address animal cruelty.

Repackaging and additions have not improved this proposed legislation, never mind deferral; please send this straight to the shredder for composting.

Comments:

Please support HCR 141 to convene a dog breeding task force. I am in support of this action because it appears that other current proposals, i.e., HB 108, contains provisions that would enable the Hawaiian Humane Society to invade a homeowner's property without a warrant should someone 'complain' that this person has more than ten dogs and is suspected to be a dog breeder. Not even the police can conduct warrantless searches on private properties!

I have raised dogs for the past 34 years, both as pets and as the occasional show dog. I belong to the Hawaiian Terrier Association, Obedience Training Club of Hawaii, the Bull Terrier Club of America, and the Staffordshire Bull Terrier Club of America. Although I do not have more than three dogs at any one time, passage of HB 108 would affect me in the future when I decide to purchase another dog. There may be no more dog breeders here in the islands. How can that be, you ask? Eventually people will no longer raise and breed show-quality purebred dogs. Currently HB 108 states that any person owning more than 10 intact dogs could be considered a breeder, hence subject to the provisions of the bill. Watch and wait for the Humane Society of the US (HSUS) to come back next year to try and persuade the legislature to reduce the number from 'over ten dogs' to something like eight or five. Most of the people I know who own and show their dogs have at least five dogs at home.

The Legislature must consult with dog breeders and dog fanciers to solicit their input instead of trying to pass unenforceable laws. Please consider the passage of HCR 141 as an attempt to gather recommendations from all those interested in the welfare of dogs and those who want to prevent any future puppy mill incidents

Thank you for the opportunity to provide the below comments on HCR 141. While we do not oppose the DCCA or any other agency convening a taskforce to further discuss the issue of dog breeding, it *should* not preclude nor prevent current legislative efforts via SB2492/HB108, to regulate large scale dog breeders.

The fact that the AKC hosts many dog shows across Hawaii has nothing to do with regulating puppy mills. Responsible breeders, regardless of AKC affiliation, and which is completely voluntary and without any enforcement authority, already meet or exceed the care provisions that were proposed under last year's SB1522 and this year's SB2492. No responsible breeder should oppose proposed standards of care if, 1) they are already meeting such standards or 2) the law would not apply to them.

We are unfamiliar with the \$3.6 million claim that the AKC states dog breeders and fanciers bring into the state. We would like to know where and how this information was gathered and what percentage of these monies are from the sale of dogs (puppies) via AKC breeders as no laws currently require that pet stores or other breeders selling dogs disclose their income related to animal sales or even the origin of the dogs they may sell to consumers. In addition, Hawaii has no USDA licensed dealers although anyone having custody of 3 breeding females and who sells more than 25 dogs per calendar year/\$500 in sales to a pet store or wholesales to another retailer is required to be licensed under the federal Animal Welfare Act.

It is important to note that Hawaii is one of but a handful of states that have no regulations on dog breeders. In fact, in our recent comparison of anti-"puppy mill" laws nationwide, Hawaii ranked 44th in the nation due to its lack of any licensing, cap on the number of dogs, standards of care for large scale commercial operations, consumer protection provisions (also known as "lemon laws") or the ability for law enforcement or animal control to conduct facility inspections.

Should this measure move forward, and to ensure adequate representation for our thousands of supporters across Hawaii, The Humane Society of the United States requests to be a member of the taskforce. Our organization has worked on legislation in at least 20 states in the last 4 years related to dog breeding and we would like to be part of any future discussion. Thank you for the opportunity to comment on this measure.

I am an exhibitor with minimum breeding. The dog shows in Hawaii bring a lot of revenue to the State. Even when I take my dogs out of State for a show, I am required to pay the State a re-entry fee to bring my dog home.

The majority of my dogs have been imported from Australia, Italy and Canada. In order for me to get these dogs processed without quarantine, they have to be processed on the mainland. The dogs do not in arrive in Hawaii until they are 7-10 months old. They also can't compete in any AKC events until they are 6 months old. I have a problem with several of the Senate Bills that count intact dogs as dogs over 6 months of age. This should be amended to a year of age or should not be regulated at all.

First, a toy dog such as a Yorkshire Terrier can't be spayed or neutered at such a young age without risking it's life. Second, I need time to evaluate my dogs in the ring to determine which ones I will show and which ones will be spayed or neutered then placed in their forever homes. I belong to several Dog Fancier clubs that have strict By-laws. One of the By-laws state that, if I sell a pet, it must be on a Spay or Neuter contract.

I have other issues with these Senate Bills dictating the allocated space in which my dogs sleep in. They start by the length of a dog under 25 inches being allowed 12 square feet. My dogs are 10-12 inches in length as are many other Toy Breeds. My dogs eat and sleep in 3×3 pens (9 square feet). The rest of the day they have 1500 square feet to run around and play. Can we not consider the Toy dog group? The majority of pet dogs in Hawaii are Toy breeds due to lack of affordable living space.

Who composed these Bills? Are they experienced enough to purpose such Bills? Have they verified if there is adequate funding to enforce these laws? Would they mandate the inspectors to have criminal background checks done prior to entering private property? Would they have a Veterinarian license to determine my dog's proper care or health? The taxpayers can't afford to pay for such expenses in this economically hard time. We already have City and County restrictions as well as Club By-laws that the legitimate dog breeders and fellow exhibitors must follow. Is there really a need for these bills? If there is, then, allow all of us to be stake holders in compiling the information for a proper Bill.

I understand that **HCR141** has been scheduled to be heard at 0915 on March 22, 2012. **I am for this Resolution.** I believe that all the stake holders should be involved when putting a Bill together. Please approve this Resolution to ensure a proper task force can be formed. Thank you for allowing me a voice and hopefully an input with a properly constructed Senate Bill.

I am the Vice President of the Shetland Sheepdog Club of Hawaii and a member and director of two other organizations: the West Oahu Kennel Club and the Obedience Training Club of Hawaii, and have been authorized to speak on their behalf.

The Community of dog fanciers and exhibitors and obedience competitors wants to stop operations like the Waimanalo "puppy mill." Our community simply opposes, however, unfocused, ineffectual, and dysfunctional legislation, such as SB2492, SB2494, and HB108 SD1.

HCR141 calls upon the Director of the Department of Commerce and Consumer Affairs to form a task force of knowledgeable stakeholders and draw upon a wide range of local knowledge and expertise on the puppy mill problem. A task force will enable the Legislature to pursue three worthy goals:

- Focus precisely upon and stop "puppy mills"
- Promote the freedom of the people to obtain the puppies and dogs of their choice
- · Draft fair laws that will be enforced on a reasonable and nondiscriminatory basis

In this regard, we note that SB2492, SB2494, and HB108 SD1 violate the above principles and owe their existence to legislative proposals originally authored by the Humane Society of the United States ("HSUS"). The HSUS is a mainland organization with no affiliation with the Hawaiian Humane Society, or other humane societies in communities around the country for that matter. Moreover, the HSUS has no animal shelter, rescue, or placement facilities of its own and contributes only a tiny fraction of its annual budget to local animal welfare organizations. At bottom, it is a lobbyist organization.

We do not need pat "answers" and the promotion of overly broad, standard form legislative proposals that restrict public choice and rely on discriminatory enforcement of dog facility and care standards that no one, not even the Hawaiian Humane Society, can satisfy.

Please resist any effort by the HSUS to insert itself into the task force or legislative process that follows. An island state, Hawaii has always found its own solutions to its often unique set of problems or conditions. Let's do so again. Let's find a local solution to the problem of puppy mills, like the one that operated in Waimanalo and the one that is apparently emerging on the Big Island. Let's do it by drawing upon the local expertise of actual stakeholders.

I ask that you support HCR141 without modification requesting the Director of Commerce and Consumer Affairs to convene a task force to get critical input from the dog fancier community before passing legislation on such an important issue.

While the intent of SB2492 and SB2494 is to govern "large scale breeding operations", it unduly burdens the hobby breeder/dog fancier. This bill is flawed with mandates such as a "12 inch clearance from the tallest dog in the enclosure", a measure from the tip of a dog's nose to the base of its tail to determine how much indoor and outdoor square footage the dogs should have "constant and unfettered" access to. There are times however when "constant and unfettered access" is not feasible or advantageous to the well-being of the dogs. For example, the last thunder/hail storm that we experienced in certain areas of the island would have caused havoc if the dogs were allowed "constant and unfettered access". They would be running around and barking in the hail storm at 6 am and catching them after being aggravated by the thunder would be unmanageable. At the first hint of thunder and rain, I brought my dogs in to ensure their safety and put them in their crates, which are their own personal space. Each of my dogs has their "own" crate, which is theirs to sleep/rest in.

They each know which crate is theirs as they sleep in these crates that do not meet the 12" clearance from the top of their heads in an air conditioned room that would not meet the 20 square feet per dog requirement. This room is a bedroom that I also sleep in. My dogs love to forage for things to play with and to eat so "constant and unfettered" access to an indoor enclosure is not always in their best interest especially when I am not in the room.

Please support HCR141 so that critical input from people who live with their dogs can be obtained before enacting bills on this important subject that will affect the safety and well-being of the dogs they purport to protect.

An owner or keeper of ten intact dogs who does not produce or sell a single puppy would be defined as a dog breeder and subject to the provisions of this bills. Among other problematic provisions, these bills would establish requirements that are detrimental to the responsible keeping and welfare of dogs, limit responsible breeders' decisions about breeding their dogs, and prohibit ownership of more than 30 intact dogs.

Additionally, biennial licensing fees, provide for unannounced inspections of private homes, allow seizure and impoundment of dogs based on infractions that are unrelated to the humane care of dogs, and establish fines of up to \$1000 per offense are being considered.

The same family is now running a replacement operation on the Big Island (Kulani Estates LLC, formed March 9, 2011 a few days after the Waimanalo seizure), presumably with the same deplorable conditions as at Waimanalo and selling the dogs at Aloha Pet Shop LLC (formed Oct 12, 2011) in Pearl City managed by Sheryl Luke-Kalani. It is maddening that the Luke family is able to flaunt the law and common decency. Operations such as theirs must be stopped.

Faulty legislation like HB108 and SB2492 will not accomplish this.
