The Maui County Council has not had the opportunity to take a formal position on this measure. Therefore, I am providing this testimony in my capacity as an individual member of the Maui County Council.

I support this measure for the following reasons:

- 1. There is a clear correlation between the visitors' impact on county infrastructure and returning a fair share of the county-earned TAT revenue to the respective county government. As Maui County begins to see a rise in visitor counts, I am concerned that any reduction to the current distribution of TAT could hinder the County's ability to fully participate in any economic recovery experienced by the State.
- Reducing the amount of TAT distributed to the counties would create an unfair imbalance as costs associated with an increase in visitor counts within a county would not be offset by a corresponding increase in revenues to that county. If the distribution of TAT does not correspond with rising visitor counts, any increase in infrastructure and public safety costs will undoubtedly fall to the counties.
- 3. Maui County's primary source of revenue is derived from real property taxes. Therefore, any reduction to the current allocation of TAT revenues distributed to Maui County could unfairly burden real property tax payers.

For the foregoing reasons, I support this measure.

Thank you for this opportunity to submit testimony in strong support of H.R. 4. My testimony is submitted in my capacity as President of the Hawai'i State Association of Counties (HSAC).

H.R. 4 was included in the 2012 HSAC Legislative Package, and urges the Governor and the State Legislature to preserve the counties share of the Transient Accommodations Tax (TAT). In 1990, the Hawaii State Legislature enacted Act 185, Session Laws of Hawaii 1990, which gave the counties a share of the TAT for the purpose of providing a more equitable method of sharing State revenues with the counties, rather than continuing the existing system at that time whereby the counties requested financial assistance through "Grants-In-Aid" from the State.

Maintaining the current allocation of the TAT provides a stable revenue source and enables the counties to properly plan when developing their budgets. This will also allow the counties to continue providing essential government programs and services for both residents and visitors alike. Losing any current allocation of the TAT may leave the counties with no choice but to raise property taxes, increase fees, and possibly reduce or eliminate government programs and services.

Thank you for the opportunity to testify in **support** of this measure. The Maui County Council has not had the opportunity to take a formal position on this matter and therefore, I am providing this testimony in my capacity as an individual member of the Council.

#### I support this measure for the following reasons:

- 1. The original intent of the transient accommodations tax ("TAT") was to raise funds for the construction of the Hawaii Convention Center which primarily benefitted the City and County of Honolulu. Instead of a municipal tax like other visitor destinations, a State tax was imposed on all accommodations. Without direct access to the facilities being constructed on Oahu with visitor industry generated funds, it became especially important for neighbor island counties to receive funds they could utilize to provide enhancements to the visitor industry in their respective communities.
- 2. A portion of TAT funds are also used for marketing costs to compete against destinations outspending Hawaii. Even with these additional marketing funds, many counties including Maui County have elected to supplementary fund marketing costs to bolster economic activity. Maui County annually contributes over \$3 million to the Maui Visitors Bureau and a loss in the TAT would lead to the elimination of this funding.
- 3. Since being given a share of the TAT, the funds have become vital to each county in offsetting the greater impact of the visitor industry on county services such as parks, beaches, water, roads, sewage systems and other tourism-related infrastructure.
- 4. Any reduction in the allocation of TAT revenues distributed to the counties' would unfairly burden residents through increases in real property taxes or other fees to maintain service costs previously offset by the TAT generated by hotels and visitor accommodations in each county.

The Hawai'i Tourism Authority (HTA) supports H.R. 4, which urges the Governor and the Legislature to preserve the counties' share of the transient accommodations tax.

In 1990, Act 185 was enacted to provide a more equitable method of sharing state revenues with the counties, in lieu of grants-in-aid. In passing this law, the Legislature noted that "...many of the burdens imposed by tourism fall on the counties." The growth of the visitor industry mean greater demands on county services, such as providing, maintaining, and upgrading police and fire protection, parks, beaches, water, roads, sewage systems, and other tourism-related infrastructure. The distribution of the TAT to the counties is meant to provide the counties with a "stable and continuing source of revenue... that will enable the counties to provide for their needs." (Conference Committee Report No. 207 (1990)).

The HTA which developed the *Hawai'i Tourism Strategic Plan: 2005-2015* in 2004, with stakeholders in government, industry and the community throughout the state, recognizes that the counties are important partners in achieving the vision of the plan. Specifically, our county partners, and their respective programs and events, are an integral part of maintaining and preserving the Hawai'i brand and enhancing the "experience" of our visitors. This includes the upkeep of counties' parks and beaches as well as the maintenance water, roads, and sewage systems. Additionally, the counties' police and fire departments are very important to the safety and security of Hawai'i's visitors.

Preserving the distribution of the TAT to the counties is important for the ability of the counties to provide these services to the visitor industry as well as contribute to the quality of life for residents.
