Senator Hee and Members of the Committee:

I write in strong support of the nomination of Shirley M. Kawamura as a Judge in the District Court of the First Circuit Court.

I have known Miki since she was a law clerk for Judge Dexter D. Del Rosario. After she joined our office in 1999, I was both her colleague and supervisor at various times. She proved to be very strong in trial practice and, had she stayed with our office long enough, she would have handled our most serious cases as one of our top trial attorneys. As it was, she handled the most serious cases at each of the levels she served as a Deputy Public Defender. In addition to her trial work, Miki volunteered to do oral argument before our appellate courts and was as outstanding in that as we knew her to be from her trial work.
