As a member of the consumer Board of the Waimānalo Health Center (WHC) I strongly support SB 2310 which appropriates funds to the Department of Human Services (DHS) to match federal funds allocated to the State for Medicaid benefits dedicated to adult vision services.

As noted in the bill, vision is an important aspect of health. Without proper vision, adults won't be able to get jobs, pay bills, and be productive members of society, which may increase the burden to the State to support these individuals. Furthermore, advanced eye disease can cause partial to complete blindness and, eye diseases, such as glaucoma, diabetic retinopathy, cataracts, etc., are primary indicators of diseases with high morbidity and mortality rates. These eye diseases can be detected and addressed with regular eye exams which can minimize the risk of morbidity/mortality and the future costs of treatment associated with these diseases.

According to the 2007 CDC data, vision disability is one of the top 10 disabilities among adults ages 18+ years with prevalence of <=200% of the federal poverty level at more than 10 times that of the general population, i.e. 26% as compared with 2-3% respectively. In addition, CDC has expressed a growing concern that the prevalence of age related eye diseases is expected to double by 2030 with the prevalence of glaucoma among people with diabetes expected to increase twelve fold by 2050. Because many eye diseases and disorders have no symptoms or early warning signs, dilated eye examinations should be performed at regular intervals to detect changes in the retina and/or optic nerve. Optometrists can view the eye for subtle changes and initiate treatment at the right time, if needed, to decrease morbidity/mortality and associated costs.

WHC, which serves a Medically Underserved Population (Native Hawaiians) in a Health Professions Shortage Area, is a vital part of Hawaii's health care system providing quality preventive and primary health care for Waimānalo, Ko'olaupoko, and beyond targeting the poor, uninsured, etc. We served 4,083 people in 22,275 visits in 2011; 26.4% of all our patients had QUEST Medicaid. We are planning to initiate vision services if start-up expenses can be subsidized. Continuation of vision services is a must for this to occur.

We appreciate the long-term, unwavering support that the Legislature has given community health centers (CHCs), patients, and communities. We urge your continued support of CHCs, WHC, and **SB2310** which provides vital funds needed for essential vision services for QUEST patients. I am writing in support of SB2310, a proposed bill that will greatly affect vision care services for Quest/Medicaid patients in the State of Hawai`i. I strongly urge you to pass this bill and preserve these much-needed medical services for low-income Quest/Medicaid patients.

As an optometric physician on Hawai`i Island, I know first hand how important it is for the underserved rural communities of this island to have access to healthcare. There is much more to an eye examination than just updating an eyeglass prescription. Every single day at my practice I come across at least one (usually much more than one) Quest/Medicaid patient whom I need to refer to another medical specialist for treatment of a previously undiagnosed serious condition.

Many times, patients will come to see me for an eye exam because they have no choice. Good vision is a requirement for obtaining or renewing a driver's license and good vision is just a necessity for everyday life. For this reason, patients will seek out vision care despite rarely visiting a general physician. Commonly, a comprehensive routine eye exam is the only opportunity to screen patients for serious medical conditions. Besides screening patients for serious sight threatening eye diseases such as glaucoma, cataracts, uveitis, diabetic and hypertensive retinopathy, macular degeneration, retinal detachments, etc., routine eye exams can also identify such serious systemic health conditions as are diabetes, hypertension, cardiovascular disease, different types of cancer including brain tumors, and many others.

It is bad enough that patients on Hawai`i Island are faced with the challenges of an overburdened health care system and doctor shortage where they oftentimes need to wait one or two months before they can get an appointment. If this bill does not pass and funding is not appropriated for these services, now Quest/Medicaid low-income patients will find themselves completely locked out of receiving these important benefits. Please stand behind these people in great need who statistically are at highest risk of the aforementioned medical problems. Do the right thing and approve funding for these medical services.
